RESOLUTION NO. XLII

A RESOLUTION AUTHORIZING THE ESTABLISHMENT OF A VOLUNTEER POLICE RESERVE FOR THE CITY OF CANBY; PROVIDING CERTAIN RULES AND REGULATIONS; AND PROVIDING AN EFFECTIVE DATE THEREFOR.

WHEREAS, it appears that a Police Reserve is needed to augment the manpower of the regular Police Department, including but not limited to such times as emergencies, vacations and sick leaves of regular police officers, days off and other manpower shortages, now therefore,

BE IT RESOLVED, by the Canby City Council in regular session convened that:

Section 1: From and after the effective date of this Resolution, the Chief of Police for the City of Canby is hereby empowered and authorized to establish, organize and maintain a volunteer Police Reserve which shall operate under the direction of the Chief of Police.

Section 2: The total membership of such Police Reserve shall not exceed twenty (20) members.

Section 3: Members of the Police Reserve shall be commissioned police officers of the City of Canby and as such, they shall have full police authority when performing the duties of a police officer. The Chief of Police shall issue commission cards to the Reserve members. The City Recorder shall administer the oath of office.

Section 4: Members in the Police Reserve shall be volunteers. Compensation for work performed shall be determined and authorized by the Canby City Council.

Section 5: The Chief of Police shall establish rules and regulations not included in this Resolution and including but not limited to qualifications and restrictions for membership, commissions, operations, training, uniforms, discipline, records and duties.

Section 6: The Police Reserve unit shall be coordinated with the City of Canby Civil Defense Director and such matters as

pertain to Civil Defense.

Section 7: When called to duty and while performing the duties of police work, the members of the Police Reserve shall be insured while on duty to the same extent as members of the City's regular Police Department.

Section 8: The Chief of Police, or in his absence, the Acting Chief of Police shall have the sole authority in calling the Reserves to duty.

Section 9: Any funds required to maintain and operate the Police Reserve shall be provided for in the City's Police Department budget.

Section 10: The Common Council of the City of Canby hereby finds and determines that it is necessary and expedient that the provisions of this Resolution shall take effect immediately in order to protect the health, safety and peace of the City of Canby and the inhabitants thereof, and this Resolution shall be in full force and effect immediately upon its adoption by the Council and approval by the Mayor. The City Council retains the right to amend, alter, change or abolish any and all sections or parts of this Resolution at any time hereafter at any regular or special meeting of the Council called for such purpose and with or without prior notice thereof.
