

RESOLUTION NO. XLIX

A RESOLUTION FIXING A DATE, TIME AND PLACE FOR A PUBLIC HEARING ON THE QUESTION OF WITHDRAWING FROM THE CANBY RURAL FIRE PROTECTION DISTRICT THAT PART THEREOF WHICH WAS ANNEXED TO THE CITY OF CANBY BY ORDINANCE NO. 469.

WHEREAS, a part of the Canby Rural Fire Protection District was recently annexed to the City of Canby in accordance with the laws of the State of Oregon and the Ordinances of the City of Canby; and said annexation was concluded by Canby City Ordinance No. 469 adopted by the Canby City Council and approved by the Mayor of said City on the 20th day of July, 1964; and

WHEREAS, the Common Council for the City of Canby has determined and does hereby determine that that part of said Fire District which was annexed to said City by said Ordinance should be withdrawn from said Fire Protection District in the manner set forth in Oregon Revised Statutes 222.524, now therefore

BE IT RESOLVED by the Canby City Council in regular session convened as follows, to-wit:


1. That the Common Council for the City of Canby, a municipal corporation of Clackamas County, State of Oregon, as the governing body of said City does hereby elect to cause the withdrawal from the CANBY RURAL FIRE PROTECTION DISTRICT of that part of said District heretofore annexed to the City of Canby by Ordinance No. 469 adopted July 20, 1964, and which said part is particularly described as follows, to-wit:

Beginning at the northwest corner of Lot 71, CANBY GARDENS; thence East along the north line of said Lot 71 a distance of 590.0 feet; thence South and parallel with east line of said Lot 71, a distance of 330.0 feet to a point in the north line of Lot 70, Canby Gardens; thence South  $10^{\circ} 18'$  East 335.4 feet to a point in the north line of Lot 69, Canby Gardens; said point being 130.0 feet west of the northeast corner of said Lot 69; thence West along said north line 134.5 feet to the northeast corner of that tract conveyed to Dora Higginbotham by the Clackamas County Deed Book 451, page 137; thence South along the east line of said Higginbotham tract a distance of 174.0 feet to the southeast corner thereof; thence West along the south line of said Higginbotham tract and said line extended 395.5 feet to a point in the west line of Lot 69; thence North along the west line of Lots 69, 70 and 71, a distance of 834.0 feet to the point of beginning.


2. That a public hearing on the question of such withdrawal shall be held at the Canby City Hall, Canby, Clackamas County, Oregon, at 8:00 o'clock p.m. Pacific Standard Time on Monday, November 2, 1964, at which hearing the Canby City Council will hear objections to the withdrawal and shall determine whether such withdrawal is for the best interest of the City.

3. That the Canby City Recorder shall and he is hereby directed to cause a Notice of the date, time, place and purpose of the hearing to be published in the Canby Herald, a newspaper of general circulation printed and published in the City of Canby once each week for two successive weeks prior to the date of hearing; and he shall also cause Notices of the hearing to be posted in four (4) public places in the City of Canby for a like period.
