

RESOLUTION NO. CXCV (195)

A RESOLUTION APPROVING CITY ENGINEER'S REPORT FOR SANITARY SEWER PROJECT ON SOUTH DOUGLAS STREET (LID#6); SETTING A TIME FOR A PUBLIC HEARING TO CONSIDER REMONSTRANCES; PROVIDING FOR THE TIME AND MANNER OF DOING THE WORK; AND AUTHORIZING A CALL FOR BIDS.

WHEREAS, The Canby City Council by motion duly made, seconded and unanimously adopted at a special meeting thereof on September 22, 1975, declared its intention to initiate sanitary sewer improvements for South Douglas Street in accordance with the provisions of Ordinance No. 393, which project is to be known as "South Douglas Street LID#6;" and

WHEREAS, the Council by said motion directed the engineering firm of Zarosinski-Tatone Engineers, Inc. of Portland, Oregon, to act as the City's engineer for such project and to make a survey and written report, and file the same with the City Recorder for Council consideration at a special meeting thereof on Monday, September 29, 1975; and


WHEREAS, the engineer's report as required and requested has been filed with the Canby City Recorder, reviewed and considered by the Canby City Council, and unanimously approved; now, therefore,

BE IT RESOLVED by the Canby City Council that:


1. The City Engineer's report for sanitary sewer improvements on South Douglas Street is approved;
2. A public hearing to consider remonstrances against the proposed project is hereby set to be held at the City Hall commencing at 8:00 p.m. on Monday, November 3, 1975, and the City Recorder is hereby directed to cause to be published forthwith once each week for two successive weeks in The Canby Herald a Notice as required by Section 4 of City Ordinance No. 393. The City Recorder is also directed to mail Notices of said public hearing to the record owners of property in the proposed improvement district and as required by Section 4 (b) of said Ordinance No. 393; and
3. The construction work for said improvement project shall be done on contract, and the City Recorder is authorized and directed to call for bids on said project which are to be received

and publicly opened at the Council chambers at the Canby City Hall at 2:00 p.m. on October 30, 1975, and considered by the Council for the award of a contract at its meeting on Monday, November 3, 1975, and following the public hearing and consideration of any remonstrances against the proposed improvement project.
