A RESOLUTION AUTHORIZING EXECUTION OF CONTRACTS FOR CONSTRUCTION OF IMPROVEMENTS TO N. CEDAR STREET.

WHEREAS, the improvement of N. Cedar Street in the City of Canby, Oregon, is required and will consist of approximately 750 lineal feet of residential street construction, including excavation, grading, subgrade preparation, concrete curbs, base rock and asphalt pavement; and

WHEREAS, the improvements required for N. Cedar Street will also include approximately 275 lineal feet of 8 inch storm drain and 2 catch basins; and

WHEREAS, the property owners on N. Cedar Street in the vicinity of the aforementioned planned improvements have previously requested the City Council to make such improvements, and said property owners have assumed and agreed to pay the **sector** construction costs and have in fact paid to the City Recorder their proportionate shares of such costs; and

WHEREAS, plans and specifications for the aforementioned improvements of N. Cedar Street have been prepared by the City's Public Works Department and calls for bids for the construction of said improvements was duly advertised in the Canby Herald, a newspaper of general circulation printed and published in Canby, Clackamas County, Oregon, on July 31 and August 7, 1974, and bids were opened and considered on August 15, 1974; and

WHEREAS, the lowest and best bid which was also an acceptable bid for the street construction, including curbs, was that of Parker Northwest Paving Company for a bid price of \$17,811.20; and the lowest and best bid which was also an acceptable bid for the storm drain construction was that of American Underground Company which was a total of \$1,520.00; and

WHEREAS, the successful bidders are ready, willing and able to proceed with the construction contracts in accordance with the

plans, specifications and proposals for said project, and it is necessary that a formal contract be approved and executed by said contractors and the City of Canby; now, therefore,

BE IT RESOLVED by the Common Council for the City of Canby, Clackamas County, Oregon, that the bid proposals of Parker Northwest Paving Company and American Underground Company on their separate bids for the construction of the N. Cedar Street improvement project and for the total bid price of \$17,811.20 (for street and curb construction) and for the total bid price of \$1,520.00 (for construction of storm drain and catch basins) are both hereby approved and accepted; and the Mayor and City Recorder are hereby authorized and directed to make, execute and deliver in the name of and on behalf of the City of Canby appropriate construction contracts with each of said contractors, and that the bid price for each project be paid upon receipt of billings and approval by the City's Public Works Department and the City Council with the funds on hand and which have been paid to the City for such purposes by the benefited property owners.
