RESOLUTION NO. CCXXI (221)

A RESOLUTION ADOPTING A SECOND SUPPLEMENTAL BUDGET AND PROVIDING FOR HEARING.

WHEREAS, the City of Canby budget for the 1976-77 fiscal tax year was approved by the voters of said City at a Budget and Tax Levy Election on September 1, 1976, and a SUPPLEMENTAL BUDGET for the expenditure of the balance of the 6/1/76 Park Bond Issue was approved after a public hearing thereon which was held January 3, 1977; and

WHEREAS, the City has now received some and will soon receive more anti-recession funds from the federal government for undesignated general purposes and another Supplemental Budget is required for the expenditure of such funds according to ORS 294.326 (1). No further voter approval is required, however, for either a tax levy or approval of this Second Supplemental Budget inasmuch as the funds now involved are a grant under federal law which are not subject to voter approval and are not subject to local ad valorem taxes; now, therefore, it is hereby

RESOLVED that:

Section 1: The following Second Supplemental Budget for the City of Canby for the 1976-77 fiscal tax year is hereby adopted, subject to any changes in the expenditure requirements which may be approved after the public hearing which is called and provided for in the following Section 3:

SECOND SUPPLEMENTAL BUDGET Proposal 1976-77

Resource: Anti-recession moneys from the Federal Government.

Receipts for 3rd and 4th quarter of 1976 calendar year.\$15,961.00 Anticipated receipts for 1st quarter of 1977 calendar year. . _6,040.00

Requirements:

1. Maintenance, improvements and salaries for maintenance and operation of Canby City parks. .\$ 7,000.00

- 2. Maintenance, improvements and salaries for swimming pool . . .\$ 8,961.00

Section 2: The Resources as shown in the SECOND SUPPLEMENTAL BUDGET are hereby appropriated for expenditure for the purposes as shown in said Second Supplemental Budget, but subject however, to any changes which may be approved after the Second Supplemental Budget hearing.

Section 3: The Second Supplemental Budget hearing is hereby called to be held at the Canby City Council Chambers in Canby, Oregon, commencing at the hour of 8:00 o'clock p.m. on Wednesday, March 16, 1977. The City Recorder is hereby directed to publish the Notice of said hearing in The Canby Herald in two successive issues commencing March 2, 1977, and post Notice of said hearing for at least ten (10) days prior to said hearing in at least three (3) public and conspicuous places in the City.
