AN ORDINANCE SETTING THE ASSESSMENTS FOR THE BROOKINGS NORTH SEWER DISTRICT.

The City of Brookings ordains as follows:

Section 1: The Proposed Assessment Roll prepared for the City of Brookings North Sewer District filed on March 5, 1979, and revised on July 3, 1979, and July 24, 1979, is hereby accepted as the assessment roll for the North Sewer District. A copy of said roll is attached hereto as Exhibit "A" and made a part hereof by reference.

Section 2: The assessments shall be made under the following rules:


- (A) Primary Benefit Area: A direct assessment on an area basis, with the maximum depth of the benefiting area to be 200 feet from the right-of-way line of the street or easement on which the sewer line is located, on all properties within the boundary of the sewer district. Assessed at \$0.14 per sq. foot.
- (B) Secondary Benefit Area: A direct assessment on the area basis on all properties within the boundary of the sewer district which are not within the Primary Benefit Area. Assessed at \$0.02 per sq. foot.
- (C) Service Connection: A direct assessment for the sewer service connection for the house lateral sewer line from the sewer main to the right-of-way line of the street or easement on which the sewer main is located. \$405.00 per each service lateral.
