

ORDINANCE NO. 280

AN ORDINANCE ADOPTING THE BUDGET OF THE CITY OF BROOKINGS FOR THE 1977-78 TAX YEAR AND SEPARATELY APPROPRIATING THE SEVERAL AMOUNTS THEREIN MENTIONED FOR THE PURPOSE THEREIN DESIGNATED, AND DECLARING THE AMOUNT OF TAXES NECESSARY TO BE LEVIED UPON THE CURRENT ASSESSMENT AND TAX ROLL, AND LEVYING THE SAME UPON ALL TAXABLE PROPERTY WITHIN THE CITY AND DECLARING THE SAME TO BE AN EMERGENCY.

THE CITY OF BROOKINGS ORDAINS AS FOLLOWS:

Section 1. WHEREAS, a hearing was held in the City Hall of the City of Brookings, Oregon, on the 12th day of July 1977, to discuss the proposed tax levy for 1977-78, and

WHEREAS, notices of said budget hearing and of all other budget information required by law to be published were published twice in the Brookings-Harbor Pilot, a newspaper of general circulation published in said city, the first publication being more than 15 days, and the second publication being more than 8 days prior to the date of said hearing;

Section 2. NOW, THEREFORE, the above mentioned budget for the tax year 1977-78, heretofore filed with the City Recorder is hereby adopted, ratified, confirmed and approved.

Section 3. A separate appropriation is hereby made for each office or officer, department, building structure, institution, bridge, street, road highway, public utility, or other purposes mentioned in said budget.

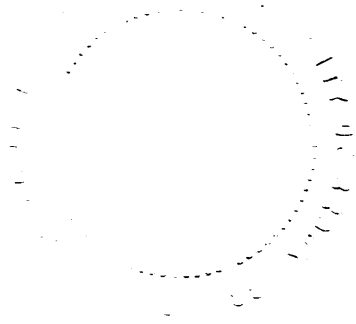
Section 4. It is hereby determined and declared that the amount of taxes to be levied upon the current assessment and tax roll is the sum of \$ 315,071.00 and that a tax of \$ 315,071.00 is hereby assessed and levied upon the real and personal property taxable within the corporate limits of the City of Brookings for the tax year 1977-78.

Section 5. The City Recorder is hereby instructed to forthwith give to the County Assessor and County Clerk of Curry County, Oregon, and the Oregon State Department of Revenue, notice in writing of said tax levy made by said city for the 1977-78 fiscal year. Said County Assessor is hereby requested to extend said levy upon the tax roll.

Section 6. Attached hereto and hereby made a part hereof is a true copy of the budget of said city as finally adopted for the year 1977-78. The total amount of money to be raised by taxation is \$ 315,071.00, of which \$ 105,400.00 is inside the constitutional limitation, \$ 115,154.00 is levied for special levy outside the constitutional limitation approved by a majority of the voters voting in election held on June 21, 1977, \$ 94,517.00 is levied for the payment of bonded indebtedness and interest thereon.

Section 7. It being necessary for the peace, health and safety of the City of Brookings that this Ordinance take effect immediately upon its passage, an emergency is declared to exist and this Ordinance shall go into effect immediately upon its passage by the council and signing by the Mayor.

Passed by the Council and signed by the Mayor this 12th day of July, 1977.
