

ORDINANCE NO. 266

An Ordinance vacating that certain alley described as follows:

An alleyway at the following location:
Between tax lots 10400 and 10900, Map
41-13-5CB, Woodland Park Addition.

THE CITY OF BROOKINGS DOES ORDAIN AS FOLLOWS:

Section 1. The Council of the City of Brookings does hereby find and determine that on November 3, 1975, Richard D. Kerr filed a Petition in writing and in due form with the City of Brookings City Recorder requesting the vacation of the following alleyway within the City of Brookings, to-wit:

An alleyway at the following location:
Between tax lots 10400 and 10900, Map
41-13-5CB, Woodland Park Addition.

That the Recorder of the City of Brookings gave due notice of public hearing to be held before the Council at the hour of 8:00 o'clock, January 13, 1976, in the Council Chambers in the City Hall in the City of Brookings at which time any persons whomsoever having any objections or remonstrance to said alleyway vacation, or any part thereof, should file written objection or remonstrance with the City Recorder. That no objections have been raised or filed to said vacation. That it appears to the satisfaction of the Council that the proposed vacation is in the best interests of the City.


Section 2. The City of Brookings does hereby vacate the alleyway in the City of Brookings, to-wit:


