

ORDINANCE NO. 103

AN ORDINANCE TO AMEND SECTION 19 OF ORDINANCE NO. 6 OF THE CITY OF BROOKINGS AND TO AMEND SECTIONS 6 AND 26 OF ORDINANCE NO. 6 OF THE CITY OF BROOKINGS AS AMENDED BY ORDINANCE NO. 80 OF THE CITY OF BROOKINGS, AND DECLARING AN EMERGENCY.

THE CITY OF BROOKINGS ORDAINS AS FOLLOWS:

Section 1: The effective date of each of the amendments and provisions of this ordinance shall be January 1, 1957.

Section 2: Section 6 of Ordinance No. 6 of the City of Brookings, as amended by Ordinance No. 80 of the City of Brookings, passed by the Council and approved by the Mayor on ~~September~~ ^{December} 13, 1955, is hereby amended to read as follows:

"Section 6: ANNUAL FEES. There is hereby levied and imposed upon each business in the City of Brookings a license tax for such business, as herein provided. The license tax for each such business for the calendar year beginning January 1, 1957 and for each calendar year thereafter shall be the sum of \$25.00. The payment of the tax and the issuance of a license for the conduct of any business prohibited by law or ordinance of the City of Brookings shall not be deemed to be the permit or license of the City of Brookings for the conduct of any business or to waive any provision of law or ordinance now or hereafter enacted regulating or prohibiting the conduct of any such business, or a part thereof. In the event the City of Brookings shall be prevented or prohibited by law from licensing and taxing any business, this ordinance shall remain and be in full force and effect as to all other businesses or branches of businesses provided to be taxed, and any such prohibition or prevention now or hereafter in effect shall not affect the validity of this ordinance as to any other business."

Section 3: Section 19 of Ordinance No. 6 of the City of Brookings is hereby amended to read as follows:

"Section 19. LICENSE PERIOD. No license provided for in this ordinance, except those licenses provided for herein on a daily basis, shall be issued for less than the full calendar year for which it is issued, provided application is made prior to July 1 of each calendar year. If application is made for the license after July 1 of each calendar year, to cover the half year period from July 1 to December³¹ of the calendar year a half year's license fee of \$12.50 shall be collected for such period or fraction thereof."

Section 4: Section 26 of Ordinance No. 6 of the City of Brookings, as amended by Ordinance No. 80 of the City of Brookings, adopted by the Council and approved by the Mayor on December 13, 1955, is hereby amended so as to read as follows:

"Section 26. COMBINATION OF CERTAIN BUSINESSES. The conduct of a business or businesses at two or more separate and distinct locations within the City of Brookings shall, for the purpose of this ordinance, be deemed to be a separate business or businesses, and each business shall be subject to the license tax herein provided for."

Section 5: It is necessary and desirable that this ordinance be in full force and effect prior to January 1, 1957, in order that its provisions may affect license fees for the calendar year 1957, and an emergency is hereby declared to exist in the interest of the public peace, health and safety of the City of Brookings and the inhabitants thereof, and this ordinance shall take effect and be in full force and effect from and after its passage at any one meeting of the Council.
