A RESOLUTION AUTHORIZING A GARBAGE COLLECTION RATE INCREASE AND ESTABLISHING A NEW RATE SCHEDULE

WHEREAS, CANBY DISPOSAL CO. has applied to the Canby City Council for approval of a Rate Increase for various kinds of Garbage Collection Service which it has been furnishing in accordance with the GARBAGE COLLECTION CONTRACT with the City dated April 23, 1970, and has furnished satisfactory evidence to the Council of its increased business costs since the current Rates were established by Resolution No. CCI (201) adopted May 3, 1976; and

WHEREAS, the City Council has considered the evidence and information furnished by the Contractor, and the Council is satisfied that the request is reasonable and justified;

NOW, THEREFORE:

BE IT RESOLVED, that the request of CANBY DISPOSAL CO. for a Garbage Collection Price Increase as set forth in the attached Exhibit "A" is hereby approved, and said Rates shall apply to the services performed under the Garbage Contract effective the 1st day of August, 1978, and shall continue thereafter until changed by Resolution of this Council.

MAJOR APPLIANCES \$2.30 - \$11.50 plus disposal fee

TIRES Less than 10 tires, 90ϕ for each tire up to 750-16 and \$1.75-\$11.50 for larger tires plus disposal fee.

For more than 10 tires, the charge shall be the hourly collection rate plus disposal fee, except by other arrangements for commercial accounts.
