

RESOLUTION NO. CCLI (251)

A RESOLUTION ESTABLISHING A NEW SCHEDULE OF PRICES AND CHARGES TO BE MADE FOR LOTS, GRAVES, GRAVE LINERS, GRAVE OPENINGS AND MONUMENT INSTALLATIONS; AND RESTATING RULES AND REGULATIONS WITH REGARD TO MONUMENTS AND MARKERS.

In accordance with the authority contained in Canby City Ordinance No. 416 adopted by the Canby City Council on July 7, 1958, and amended by Ordinance No. 467 enacted July 6, 1964, which relate to the control and operation of Zion Memorial Park, formerly Zion Cemetery, the Canby City Council has determined that increased prices and charges should be made for grave openings and closings, grave liners and Saturday Services; and that the rules and regulations for the cemetery should be restated;

NOW, THEREFORE, BE IT RESOLVED by the Canby City Council that the following schedule of charges for sales and services in the Zion Memorial Park shall apply on and after October 19, 1978, and continuing until changed by subsequent Resolution of the Canby City Council:

BE IT FURTHER RESOLVED that the rules and regulations of Zion Memorial Park, formerly Zion Cemetery, adopted January 10, 1938, revised July, 1949, restated November 4, 1974 by Resolution No. CLXXXII (182) and restated February 2, 1977 by Resolution No. CCXVIII (218) are hereby restated again as follows:

A. Raised stones or monument markers will be allowed only in those sections of the cemetery which now contain raised stones or monument markers as of this date and which areas are defined as all areas in the "old Section" and Blocks N, O, S, T and U in the new section of the cemetery.


B. Except in those areas now containing raised stones or markers as defined in the foregoing paragraph A, monuments or markers in other areas of the cemetery must be flat, bronze or quarry granite of modern design. Each grave may be marked with a flat bronze marker or with a polished quarry granite marker, and such markers must be 12" X 24" for adults and 10" X 20" for children and 3" to 6" thick and set level with the ground; letters on bronze markers may be raised but letters on granite markers must be sunk deep; and no foot stone shall be permitted.

BE IT FURTHER RESOLVED that all prior price schedules and rules and regulations of the Zion Memorial Park which are different than or contrary to the provisions of this Resolution are now changed and superseded by the provisions of this Resolution.
