

RESOLUTION NO. CCLXXV (275)

A RESOLUTION AUTHORIZING INCREASE IN RATES UNDER GARBAGE FRANCHISE CONTRACT WITH CANBY DISPOSAL CO.

WHEREAS, Canby City Ordinance No. 401 provides for the City to contract for garbage collection service; and

WHEREAS, a contract was entered into between the City and Canby Disposal Co. and the contract provides that the rates, which shall be reasonable and uniform, shall not be in excess of the scheduled charges approved by the City and that said charges may be revised to reflect changes in cost of doing business and other factors; and

WHEREAS, the Franchisee has applied for an increase in the maximum rates authorized and the Canby City Council has considered the request and presentation of the Franchisee, and the City Council has found the following:

1. That the last rate increase was approved by the City Council effective August 1, 1978.

2. That there has been a substantial increase in the cost of doing business for the Franchisee since the last increase.

3. That the rate increase requested is fair and reasonable and needed to give the contract Franchisee a reasonable rate of return so as to provide good and efficient service.


THEREFORE, IT IS HEREBY RESOLVED by the Canby City Council that Canby Disposal Co. of Canby, Oregon, is entitled to charge the rates on the attached Exhibit "A" after February 1, 1980.

CITY RATE SCHEDULE EFFECTIVE FEB. 1, 1980

RESIDENTIAL 32 gallon can - AT CURB

1 can per week \$4.30 per month
2 cans per week \$6.90 per month
Each additional can \$2.60 per month

RESIDENTIAL 32 gallon can - WITHIN 50 FEET OF CURB

1 can per week \$4.80 per month
2 cans per week \$7.65 per month
Each additional can \$2.85 per month

RESIDENTIAL 32 gallon can - BEYOND 50 FEET FROM CURB

1 can per week \$5.05 per month
2 cans per week \$8.05 per month
Each additional can \$3.00 per month

All customers using curb service must place can at the curb by 6:00 a.m. on collection day and remove can by the evening of collection day.

COMMERCIAL 32 gallon can

1 can per week \$5.30 per month
2 cans per week \$8.00 per month
Each additional can \$3.30 per month

MOBILE COURTS AND COURT APARTMENTS - 4 or more units where owner accepts and pays billing

AT CURB

1 can per week \$3.65 per month
2 cans per week \$6.05 per month
Each additional can \$2.40 per month

NOT AT THE CURB

1 can per week \$4.00 per month
2 cans per week \$6.60 per month
Each additional can \$2.60 per month

NOTE: (1) If mobile court units and court apartments have to be billed separately, the regular residential charge applies.

(2) Each additional stop per week will be at the same rates as above.

STRAIGHT HANDLING CHARGE For Once a Month Service

\$2.35 for first can \$1.35 for each additional can

EXTRA CHARGE FOR STAIRS

1 flight of stairs 25% additional
2 flights of stairs 50% additional

HOURLY HAULING RATES

Truck and 1 man - \$40.00 per hour plus disposal fee
Truck and 2 men - \$54.00 per hour plus disposal fee

MAJOR APPLIANCES

\$2.75 - \$13.50

TIRES

Less than 10 tires, \$1.05 for each tire up to 750x16 and \$2.00-\$13.00 for larger tires plus disposal fee.

For more than 10 tires, the charge shall be the hourly collection rate plus disposal fee, except by other arrangements for commercial accounts.

NOTE: The rate for compacted containers provided by the customers shall be 2,5 times the loose rate for the same sized container. Customers desiring to purchase compacted containers or compacted drop boxes must check with the Franchisee to see that the compactor unit being purchased is compatible with the equipment the Franchisee has or is willing to obtain.

COMPACTED DROP BOX RATES

Twenty-Twenty-nine Cu. Yd. \$3.49 per cubic yard plus disposal fee
 Thirty-Thiry-nine Cu. Yd. \$3.11 per cubic yard plus disposal fee
 Forty & Over \$2.73 per cubic yard plus disposal fee

Note: Compactor Drop Boxes must not be compacted to the point where the loaded vehicle will exceed truck weight laws or to the point where the Compactor Drop Box cannot be dumped by normal dumping methods.

DEMURRAGE CHARGE

Permanent Accounts - \$40.00 per month
 Occasional Accounts - \$3.00 per day after 48 hours.

GENERAL NOTES:

- (1) Source separated recyclables will be hauled for the normal hauling rate plus mileage of \$1.00 per mile beyond a 25 mile round trip, minus the normal disposal fee.
 - (2) Where additional disposal fees must be paid by the Franchisee for such items as car seats, brush or stumpage, the Franchisee may add the additional disposal fee.
 - (3) A reasonable additional fee may be charged for Saturday service.
