

RESOLUTION NO. CCCXVI (316)

A RESOLUTION DESIGNATING TRUCK ROUTES; PROHIBITING USE GENERALLY OF OTHER STREETS, ROADS AND HIGHWAYS FOR OPERATION OF TRUCKS, MACHINERY OR HEAVY VEHICLES; AND PRESCRIBING PENALTIES FOR VIOLATIONS.

1) Pursuant to the provisions of ORS 483.542 authorizing municipal authorities to designate truck routes, the Canby City Council hereby resolves to designate and does hereby designate the following streets, roads and highways within the Canby city limits as truck routes and the operation of trucks, machinery or heavy vehicles on all other streets, roads, and highways in the City of Canby is prohibited except for local deliveries on or within the immediate area of such other streets, roads or highways:

Highway 99-E from east to west city limits
S.E. Second from South Pine east to city limits
S. Pine Street
S. Juniper from 99-E to S.E. Second Avenue
S.E. Second Avenue from S. Ivy to S. Juniper
S. Ivy from 99-E to S.W. 13th Avenue
Berg Parkway
N.E. 4th Avenue from 99-E to N.E. 3rd Avenue
N. Ivy from 99-E to N.W. 3rd Avenue
N.W. 3rd Avenue from N. Ivy to N. Holly
N. Holly from N.W. 3rd Avenue to north city limits
N. Elm from 99-E to N.W. 3rd Avenue
N.W. 3rd Avenue from N. Elm to west city limits
N.W. Baker Drive from N.W. 3rd Avenue to N.W. 6th Avenue
N.E. Territorial Road from East city limits to N. Juniper Street

A City map designating the above described truck routes is attached hereto and by this reference and its attachment is expressly made a part of this resolution.

2) The City's Superintendent of Public Works is hereby authorized and directed to erect and maintain signs giving notice of this resolution, in a conspicuous manner and place at each end of the highway affected.

3) No person shall operate a vehicle or combination of vehicles in violation of this resolution after the signs giving notice of this resolution are erected; and a person who violates the order of this resolution commits a Class C traffic infraction and shall be punished accordingly. The Canby Police Department is directed to enforce compliance with this resolution.

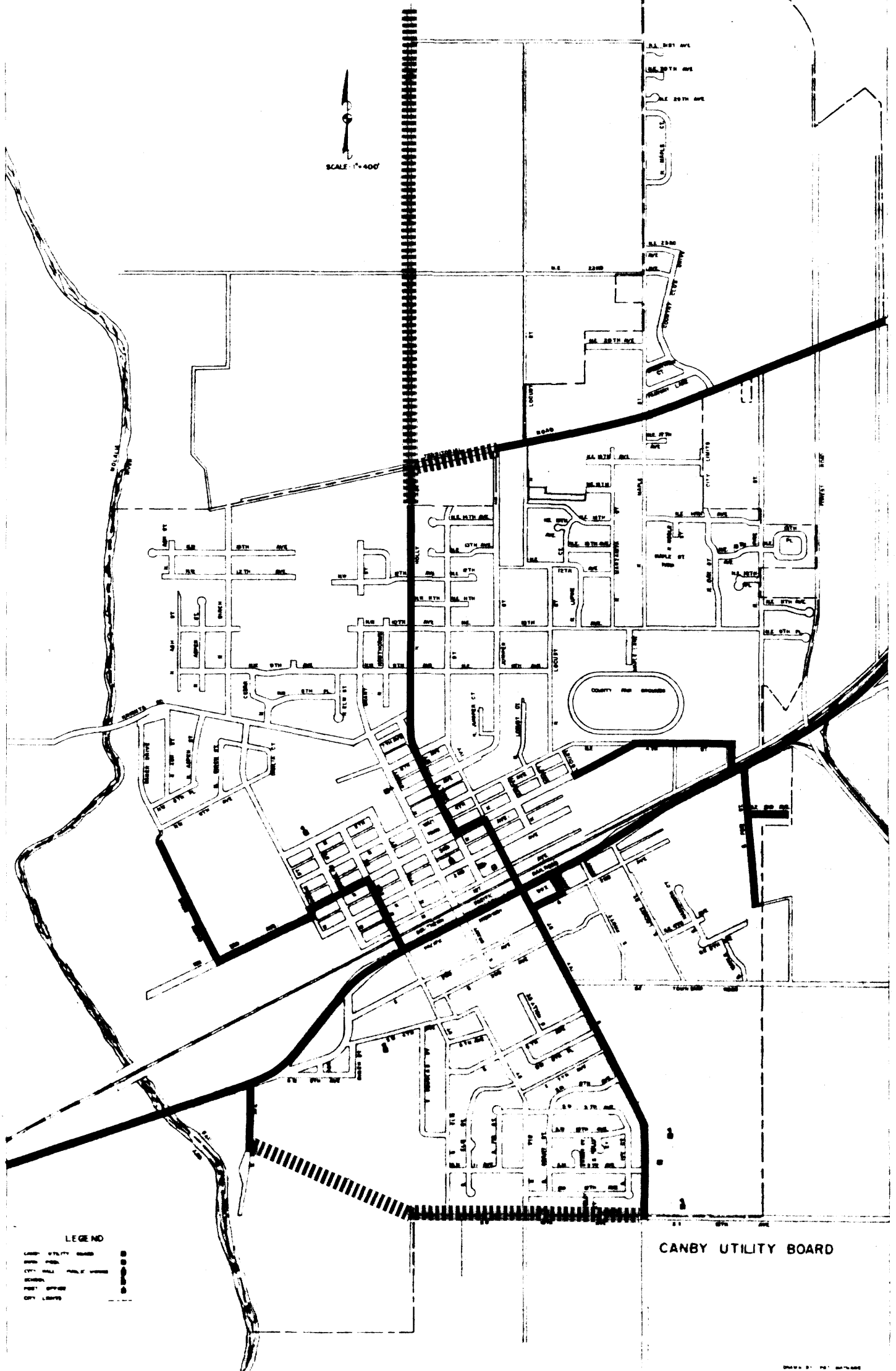
