

RESOLUTION NO. CCCXVII (317)

A RESOLUTION AUTHORIZING AWARD OF REROOFING CONTRACT FOR SWIMMING POOL OFFICE AND DRESSING ROOM AREA.

WHEREAS, the City of Canby has heretofore published a call for quotes to reroof the City's swimming pool office and dressing room area according to plans and specifications prepared by the City's Superintendent of Public Works and previously approved by the council; and

WHEREAS, the notice and call for quotes was duly and regularly given by publication in the Canby Herald on June 2, 1982; and

WHEREAS, five quotes were received as requested and reported to the Mayor and City Council by the Superintendent of Public Works in a memorandum dated June 4, 1982, and the following quotes were received:

WHEREAS, the Canby City Council as the City's Contract Review Board met in special session on June 9, 1982, and considered the quotes and reports and recommendation of the City's Superintendent of Public Works and concluded that the lowest and best quote was that of G.K.B., Inc., P. O. Box 500, Canby, Oregon for the amount of \$3,598; now, therefore,


The Canby City Council hereby RESOLVES to proceed with the swimming pool facilities repair project and that G. K. B., Inc. submitted the lowest and best bid for the work now required to be done and a contract with that company is authorized for reroofing the Canby swimming pool office and dressing room area for the bid price of \$3,598.

The construction work for this project shall be done under the supervision

of the City's Superintendent of Public Works and in accordance with his plans and specifications for such project; and payment on said contract shall be made upon completion of the job, acceptance by the City's Superintendent of Public Works, and approval of the City Council, and such payment shall be made from the City's Revenue Sharing Fund in the 1981-82 budget.

The City Attorney is hereby authorized and directed to prepare an appropriate contract between the City and G.K.B, Inc. for the repair project and construction work authorized by this resolution, and which is to be signed for the City by the Mayor and attested by the City Recorder Pro Tem.
