A RESOLUTION AUTHORIZING AND APPROVING A JOINT AGREEMENT OF FUNDING FOR CANBY COMMUNITY SCHOOL FOR FISCAL YEAR 1982-83.

WHEREAS, the City of Canby, Canby Union High School and Clackamas Community College have engaged in a cooperative program for Canby Community School which has found wide acceptance in the community and is generally recognized as a most beneficial endeavor for the many participants and the community as a whole; and

WHEREAS, the City's current budget includes an amount for the City's share of money needed for the planned program in the 1982-83 fiscal year and the three participants will share responsibility and costs in accordance with an agreement which has been prepared and recommended for approval by all concerned, and a copy of the same is attached hereto marked "Exhibit A" for identification purposes and by this reference and its attachment is made a part hereof; and

WHEREAS, the Canby City Council has in the past and does now support and endorse this program and approves the contract as proposed; now, therefore, it is hereby

RESOLVED that:

 The Mayor and City Administrator are hereby authorized and directed to sign, date and deliver on behalf of the City of Canby the signature copies of "Exhibit A" and in as many counterparts as may be required; and

2) That the City's share of the cost of this program be paid from the proper budget line item on or after June 15, and before June 30, 1983; and

3) That the City Administrator advise the other participants of the council's decision and action by furnishing certified copy of this resolution and pay the City's share of the costs as herein directed and without further order of the council.

JUINT AGREEMENT OF FUNDING

FOR

CANBY COMMUNITY SCHOOL

CANBY UNION HIGH SCHOOL DISTRICT CITY OF CANBY CLACKAMAS COMMUNITY COLLEGE

Pursuant to the resolution for joint sponsorship of Canby Community School, this agreement establishes the financial responsibility of each of the above.

This agreement is effective from July 1, 1982 to June 30, 1983 unless at least sixty (60) days written notification is given to all other sponsors.

Canby Union High School District will assume responsibility to budget for the entire Community School Program with the exception of the Community Development Coordinator position. Clackamas Community College will hire a Community Development Coordinator (11-month contract) to work within the Canby Union High School District. The Coordinator will be placed in the Community School Office and work as a part of the local Community School staff. Funding by the City of Canby and Clackamas Community College will be recorded in the Canby High School budget as revenue.

Canby Union High School will bill the City of Canby and Clackamas Community College by June 15, 1983 for their annual commitment.

The funding breakdown for the 1982-83 fiscal year shall be:

Canby Union High School will assume the additional in-kind expenses incurred from office space and extended use of that facility.
