

RESOLUTION NO. 422

A RESOLUTION ADOPTING BUDGET AND MAKING APPROPRIATIONS FOR
THE 1989-90 FISCAL YEAR

WHEREAS, the City's budget and Two Year Serial Levy Election for the 1989-90 fiscal year was held in and for the City on March 28, 1989, and that measure, which was a "TWO YEAR SERIAL LEVY FOR EMERGENCY SERVICES" was approved in the amount of \$792,935. The public hearing on this measure had been duly and regularly advertised and held on February 15, 1989, and the budget as prepared by the City's Budget Committee was approved by the Council after that hearing. The Budget document is now on file in the office of the Canby City Recorder and the funds as shown therein must now be appropriated for the required expenditures; and

NOW, THEREFORE, BE IT RESOLVED THAT the City Council of Canby hereby levies the taxes provided for in the adopted budget in the aggregate amount of \$ 792,935; and that these taxes are hereby levied upon the assessed value as of 1:00 a.m., January 1, 1989, on all taxable property within the City.


