## **RESOLUTION NO. 440**

A RESOLUTION AUTHORIZING A GARBAGE COLLECTION RATE INCREASE FOR PASS-THROUGH OF INCREASED DISPOSAL FEES AND ESTABLISHING A NEW RATE SCHEDULE

WHEREAS, CANBY DISPOSAL COMPANY has applied to the Canby City Council for approval of a rate increase to pass-through to customers the increased disposal fees in accordance with the Solid Waste Collection Ordinance No. 793, Section 14, dated June 18, 1986, and has furnished satisfactory evidence to the Council of its increased business costs related to the increase in disposal fees; and

WHEREAS, the City Council has considered the evidence and information furnished by the Franchisee, and the Council is satisfied that the request is reasonable and justified.

NOW, THEREFORE, BE IT RESOLVED that the request of Canby Disposal Company for a garbage collection rate increase to passthrough to collection customers the increased disposal fees, as set forth in the attached EXHIBIT "A" is hereby approved, and said rates shall apply to the services performed under the Solid Waste Management and Recycling Ordinance effective the 1st day of October, 1989, nun pro tunc.

## DEMURRAGE CHARGE

Permanent Accounts = \$46 per month;Occasional Accounts = \$4.60 per day after 48 hr GENERAL NOTES: (1) Source separated recyclables will be hauled for the normal hauling rate plus mileage of \$1.33 per mile beyond a 18 mile round trip, minus the normal disposal fee. (2) Where additional disposal fees must be paid by the Franchisee for car seats, brush, stumpage or other items, the Franchisee may add the additional disposal fee to the customer's bill. (3) A reasonable additional fee may be charged for Saturday service.

EXHIBIT "A"

A RESOLUTION SETTING INDUSTRIAL WASTE DISCHARGE LIMITS, REQUIRING INDUSTRIAL WASTE DISCHARGE PERMITS FEES, AND ESTABLISHING FEES AND CHARGES FOR THE TESTING OF INDUSTRIAL WASTE.

WHEREAS, the Canby City Council is required by Ordinance No. 835 to establish discharge limits for organic pollutants that may be introduced into the municipal sewer system, and

WHEREAS, the following discharge limits have been recommended to the Council by the Public Works Superintendent and are in accordance with the Clean Water Act (33USC. 1251 et. seq.), and

WHEREAS, all industrial users are required under the Industrial Pretreatment Program to obtain an Industrial Wastewater Discharge Permit which will be valid for two (2) years, and

WHEREAS, all industrial users under the Industrial Pretreatment Program will be sampled bi-annually for compliance monitoring and will pay the costs for laboratory analyses.

NOW, THEREFORE, the Canby City Council resolves as follows:

Section 1. The following discharge limits are established effective immediately for organic pollutants set forth below:
