

RESOLUTION NO. 534

A RESOLUTION PRESCRIBING A BALLOT TITLE BY THE CITY COUNCIL FOR THE INITIATIVE TO BE PLACED ON THE JUNE 29, 1993 BALLOT

WHEREAS, the City of Canby received the number of signatures required by Municipal Code 1.12.070 for an initiative to be placed on the ballot; and

WHEREAS, the Clackamas County Elections Department certified the required number of signatures; and

WHEREAS, the City Attorney, in the prescribed time period at prescribed by Municipal Code 1.12.100, prepared a ballot title to be best of his ability giving a true and impartial statement of the purpose of the proposed initiative; and

WHEREAS, in accordance with Municipal Code 1.12.100 the City Attorney's ballot title was challenged; and


WHEREAS, the challenge set forth a different title giving the reasons therefore, and asking for the Council to consider their title, now therefore it is hereby


RESOLVED that the Canby City Council will prescribe the following ballot title for the initiative as prescribed in "Exhibit A" hereto attached.

FURTHER RESOLVED that the ballot title approved by the City Council will be placed on the June 29, 1993 ballot as prescribed by Canby Municipal Code 1.12.100

QUESTION (20 Words) Shall City Charter be amended to prohibit minority
or other special status for homosexuals or expending
funds to promote homosexuality?

*SUMMARY Amends City Charter, prohibits City from extending minority status based on homosexuality, sexual orientation or preference and from enforcing such laws. Prohibits City spending to promote or approve homosexuality. Does not deny City services based on lawful sexual practices. Does not limit public library materials for adults. Does not nullify civil rights based on race, religion, color, sex, marital status, familial status, national origin, age or disability. Does not limit constitutional rights. Allows laws which prohibit employment decisions based on non-work related reasons.
