A RESOLUTION ESTABLISHING FEES FOR THE CANBY SWIM CENTER AND CITY PARK FACILITIES

WHEREAS, the Canby City Council has prescribed by Ordinance No. 920, that fees for the use of the Canby Swim Center and Canby Park facilities shall be set and approved by resolution; and

WHEREAS, the Canby City Council has determined that the rates hereinafter specified are just, reasonable and necessary; and

WHEREAS, Oregon law requires that a governing body, when adopting a new fee resolution imposing new rates, may include a provision classifying said fees as subject to or not subject to the limitations set in Section 11 (b), Article XI of the Oregon Constitution, now therefore it is hereby

RESOLVED that effective immediately, fees to be charged for use of the Canby Swim Center and the City Park facilities are established as set forth in Exhibit A and Exhibit B, attached hereto and by this reference incorporated herein.

BE IT FURTHER RESOLVED that the Canby City Council hereby classifies the fees imposed herein as not subject to the limitations imposed by Section 11 (b), Article XI of the Oregon Constitution and that the City Recorder is hereby directed to publish a notice in accordance with Oregon law.
