RESOLUTION NO. 680

A RESOLUTION OBJECTING TO A MINOR BOUNDARY CHANGE BY THE PORTLAND METROPOLITAN AREA LOCAL GOVERNMENT BOUNDARY COMMISSION APPROVING OF THE ANNEXATION TO THE CITY OF CANBY, CLACKAMAS COUNTY, OREGON OF TAX LOT 2000 OF TAX MAP 4-1E-3, LOCATED ON THE NORTH SIDE OF SE 13TH AVENUE EAST OF S. REDWOOD STREET AND SOUTH OF SE TOWNSHIP ROAD (PMALGBC File No. 3935).

WHEREAS, the Portland Metropolitan Area Local Government Boundary Commission (PMALGBC) held a hearing on August 20, 1998 to consider a minor boundary change application by Oregon Development, Inc. and Larry and Betty Faist for Tax Lot 2000 of Tax Map 4-1E-3, located on the north side of SE 13th Avenue east of S. Redwood Street and south of Township Road (PMALGBC File No. 3935). At the conclusion of said hearing, the PMALGBC approved the change; and

WHEREAS, pursuant to ORS 199.505(1)(b), the Canby City Council wishes to object to the proposed boundary change and wishes to refer the PMALGBC's approval to the electors of the City of Canby; and

WHEREAS, pursuant to ORS 199.505(2) and (3), the Canby City Council, having objected to the proposed boundary change, must call and hold an election in the City on the next appropriate election date as authorized by ORS 221.230;

NOW THEREFORE, IT IS HEREBY RESOLVED by the City Council of the City of Canby, as follows:

1. Pursuant to ORS 199.505(1)(b), the Canby City Council hereby objects to approval of the minor boundary change by the PMALGBC for an application brought by Oregon Development, Inc. and Larry and Betty Faist for Tax Lot 2000 of Tax Map 4-1E-3, located on the north side of SE 13th Avenue east of S. Redwood Street and south of Township Road, approved by the PMALGBC on August 20, 1998.

2. The City Recorder of the City of Canby is hereby authorized and directed to hold an election through the Clackamas County Election Department on November 3, 1998, the next appropriate election date as authorized by ORS 221.230.

3. The City Recorder, the City Administrator and the City Attorney are hereby authorized to do all other necessary and proper acts to place the matter before the voters at the election of November 3, 1998.
