RESOLUTION NO. 710

RESOLUTION REQUESTING CLACKAMAS COUNTY TO SURRENDER A JURISDICTION OVER A CERTAIN PORTION OF SOUTH EAST FIRST AVENUE WITHIN THE CITY LIMITS.

WHEREAS, a certain portion of South East First Avenue is scheduled to be abandoned to accommodate the Gramor Canby Market Center project as approved by the City Planning Commission and to allow new design, engineering and construction of a temporary South East First Avenue by Gramor of Oregon, Inc.; and

WHEREAS, the City desires to have the abandonment of a certain portion of said street in accordance with the City requirements; and

WHEREAS, the City desires to have final approval and control of the said design. engineering and resulting work to insure compliance with City standards; and

WHEREAS, pursuant to ORS 373.270(6)(a), the city council may initiate the surrender of county jurisdiction over a county road by passage of appropriate municipal legislation (resolution) and may set any time or other limitations upon acceptance by the city of the surrender; and

WHEREAS, due to the nature and timing of the abandonment, the completion of the design and engineering, and the work underway, time is of the essence and the city desires to have the surrender of jurisdiction over the said street by the county order as soon as possible; and

WHEREAS, there are no other known limitations the city desires to impose on the acceptance by the city.

NOW, THEREFORE, BE IT RESOLVED:

Clackamas County is hereby requested to surrender jurisdiction over the certain portion of South East First Avenue as described on the attached Exhibits "A" (legal description) and "B" (drawing) incorporated herein by reference; and

BE IT FURTHER RESOLVED:

Clackamas County is hereby requested to surrender jurisdiction over said portion of South East First Avenue forthwith and without other city limitations.

Legal Description

A 40.00 foot wide strip of land, located in the Philander Lee Donation Land Claim No. 56, being within Section 34, Township 3 South, Range 1 East, of the Willamette Meridian, Clackamas County, Oregon, being 20.00 feet on each side of the following described centerline:

Commencing at a 4-1/2" aluminum cap monumenting the West one-quarter corner of Section 34 and an angle point in the northerly boundary line of the Philander Lee Donation Land Claim No. 56; thence N 63°56'06" E 1384.95 feet along said northerly boundary line and the westerly extension of the centerline of 1st Avenue (County Road No. 687), to the Point of Beginning of said 40.00 foot wide strip, said point coincident with the southerly right-of-way line of U.S. Hwy 99E being 50.00 feet southerly of when measure at a right angle to the centerline of said U.S. Hwy 99E; thence continuing along said northerly boundary line and said centerline N 63°56'06" E 607.50 feet to the Point of Terminus, said point bears S 63°56'06" W 932.18 feet from a ³/₄" iron pipe monumenting an angle point in said northerly boundary line.

The sidelines of said 40.00 foot wide strip of land shall be lengthened or shortened to conform to the grantors property lines.
