## **CITY OF CANBY RESOLUTION NO. 729**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CANBY COMMITTING THE CITY TO JOINT FUNDING AND POOLING OF LABOR, MATERIALS AND EQUIPMENT **RESOURCES AND ENCOURAGING THE** CLACKAMAS COUNTY BOARD OF COMMISSIONERS TO LIKEWISE COMMIT THE COUNTY TO JOINT FUNDING AND POOLING OF LABOR, MATERIALS AND EQUIPMENT RESOURCES FOR MUTUALLY AGREED UPON COUNTY ROAD PROJECTS WITHIN THE CANBY COMMUNITY.

WHEREAS, many of the county roads within the City of Canby are in disrepair, in need of higher level of maintenance or upgrade and, in many cases, require reconstruction due to their poor to failing condition; and

WHEREAS, the citizens of Canby and Clackamas County have expressed their desire to have all county roads in reasonable and safe repair, upgraded to meet traffic demands, and reconstructed where necessary; and

WHEREAS, the City Council and the Clackamas County Board of Commissioners have expressed their desire to have all county roads in reasonable and safe repair, upgraded to meet traffic demands, and reconstructed where necessary; and

WHEREAS, the City Council recognizes that there are limited county and city funds and resources to achieve the results desired by the Canby and Clackamas County communities; and

WHEREAS, the City Council commits and wishes that the Clackamas County Board of Commissioners commits to joint funding and pooling of labor, materials and equipment resources for maintenance, upgrade and reconstruction of county roads within the Canby and Clackamas County communities; and

WHEREAS, The City Council believes that the time is now for the county and city to develop and implement joint and coordinated funding and pooling of labor, materials and equipment resources to deliver quality roads to city and county citizens.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Canby that City of Canby hereby commits the City to joint funding and pooling of labor, materials and equipment resources and encourages the Clackamas County Board of Commissioners to likewise commit the County to joint funding and pooling of labor, materials and equipment resources for mutually agreed upon county road projects within the Canby community.
