

RESOLUTION NO. 734

A RESOLUTION ESTABLISHING SALARY COMPENSATION SCALES FOR MANAGEMENT PERSONNEL OF THE CITY OF CANBY, ESTABLISHING VARIOUS RANGES FOR SALARY LEVELS , DIRECTING THE CITY ADMINISTRATOR TO PLACE INCUMBENT EMPLOYEES WITHIN THE APPROPRIATE SCALE AND RANGE, ESTABLISHING AN EFFECTIVE DATE AND REPEALING RESOLUTION 722.

WHEREAS, the City of Canby passed Resolution 722 on December 1, 1999, establishing salary compensation scales for management personnel of the City.

WHEREAS, the implementation of the salary levels was established using three effective dates as set forth in Attachments A, B and C to Resolution 722. Salary levels as set forth in Attachment A were implemented effective December 1, 1999 through June 30, 2000 .


WHEREAS, the City Council finds that certain changes need to be made in the salary level ranges for Attachments B and C, effective July 1, 2000 through June 30, 2001 and July 1, 2001 through June 30, 2002 respectively, by adding an additional Step 6 for Police Lieutenant ,

NOW THEREFORE, IT IS HEREBY RESOLVED by the City Council of the City of Canby, as follows:

1. That Attachments B and C to this Resolution are adopted for the time periods specified.
2. That the City Administrator is directed to take the necessary action to place incumbent employees not previously placed within the appropriate range and step effective July 1, 2000.
3. That all subject employees shall hereafter be eligible for an increase of one step at their anniversary date upon receipt of a satisfactory performance evaluation by their supervisor.
4. That the effective date of this Resolution is July 1, 2000.


5. That Resolution 722 is repealed and superceded by Resolution 734 effective July 1, 2000.
