

**CITY OF CANBY
RESOLUTION NO. 746**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CANBY IN SUPPORT OF
THE CIRCULATION OF A PETITION TO WITHDRAW FROM TRI-MET AMONG THE
ELECTORS WITHIN THE CITY OF CANBY AND THE CANBY URBAN GROWTH
BOUNDARY.**

WHEREAS, State Representative Kurt Schrader sponsored legislation in 1999 that was enacted which provided the City of Canby the opportunity to petition to withdraw from TRI-MET and to provide city operated public transportation; and

WHEREAS, the City Council at their meetings of March 15, 2000 and April 19, 2000 authorized the engagement of Portland State University to provide it with a Canby Community Transportation Needs Assessment; and

WHEREAS, the City Council at their September 6, 2000 and October 4, 2000 meetings appointed 26 community members representing a wide variety of community interests to the Canby Public Transportation Task Force; and


WHEREAS, the City Council at their December 6, 2000 meeting accepted the Portland State University Canby Community Transportation Needs Assessment presented by Dr. Tom Sanchez of PSU and the Canby Public Transportation Task Force; and

WHEREAS, the Canby Public Transportation Task Force held public meetings and accepted public input during the period September 2000 through January 2001; and

WHEREAS, the Canby Public Transportation Task Force and city staff have discussed, reviewed and recommended the circulation of a Petition to Withdraw from TRI-MET to the electors of the City of Canby and the Canby Urban Growth boundary.

NOW, THEREFORE, BE IT RESOLVED by the City Council that City of Canby hereby supports the circulation of the attached Elector's Petition to Withdraw from TRI-MET, marked "Exhibit A" and incorporated herein by reference.



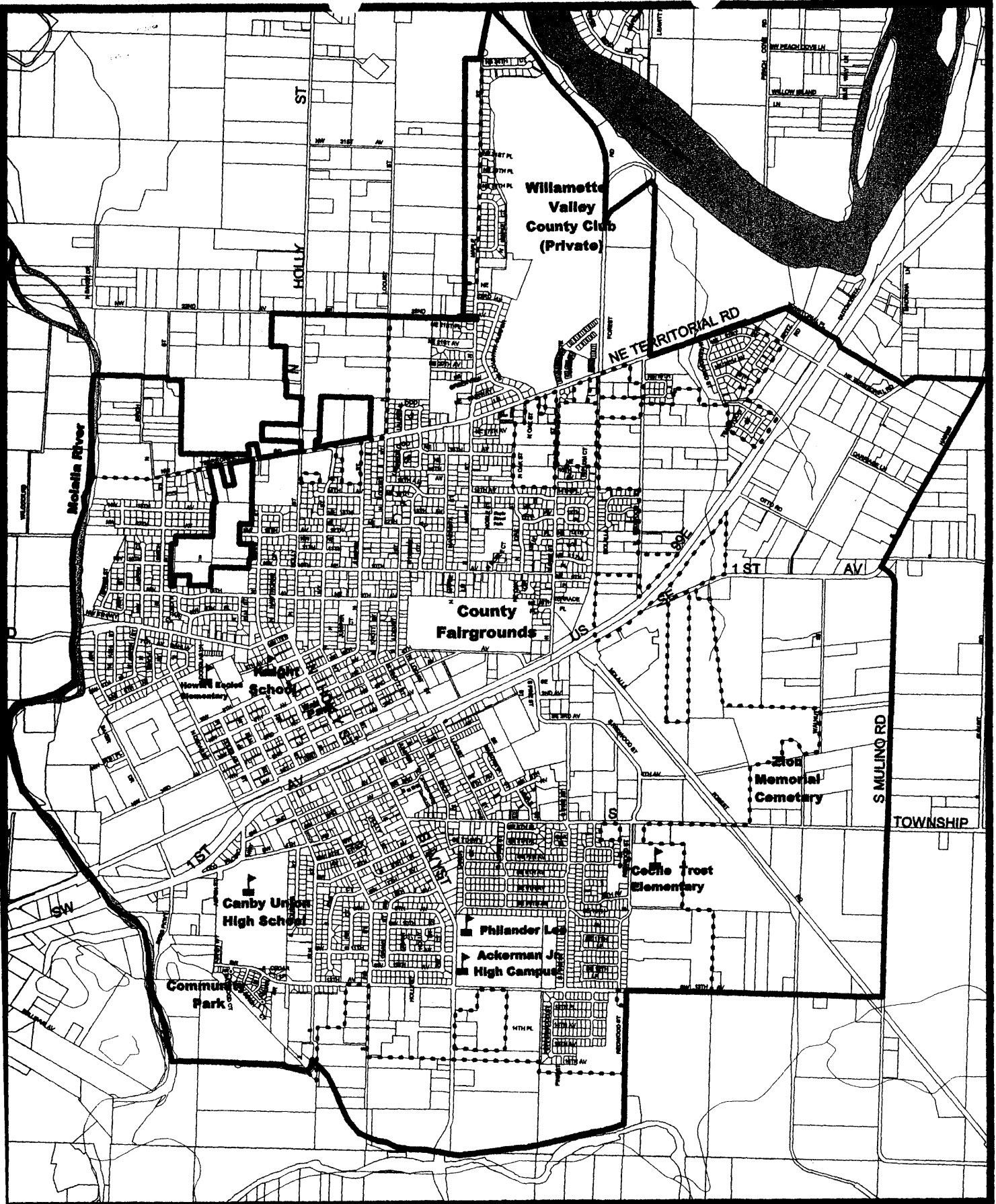
PETITION FOR WITHDRAWAL FROM TRI-MET
