## **RESOLUTION NO. 809**

# A RESOLUTION TO ACCEPT A RIGHT-OF-WAY DEDICATION FOR ROAD PURPOSES OF PROPERTY ALONG S.W. BERG PARKWAY LOCATED JUST WEST OF SAFEWAY STORE FROM OREGON FOOD STORES, INC., AN OREGON CORPORATION.

WHEREAS, the Canby City Planning Commission approved a design review application for improvements to property owned by Oregon Food Stores, Inc., to accommodate a new Safeway store and shopping center located on Highway 99 E in Canby, near S.W. Berg Parkway. As a condition of approval of the application, Oregon Food Stores, Inc., agreed to dedicate a portion of its property for right-of-way purposes along the boundary with S.W. Berg Parkway in order to widen S.W. Berg Parkway; and

**WHEREAS**, CMC 16.88.060 requires the Canby City Council accept all property proposed to be dedicated to the City; and

WHEREAS, Oregon Food Stores, Inc., has proposed to dedicate a portion of its property to the City for road purposes, a copy of the legal description of the property is attached to the Deed for Road Purposes as Exhibit "A"; and

**WHEREAS**, the City Council believes this right-of-way would be a valuable asset to the City of Canby street system;

**NOW THEREFORE, IT IS HEREBY RESOLVED** by the City Council of the City of Canby, as follows:

<u>Section 1</u>. The Canby City Council accepts the Right-of-Way Dedication Deed for Road Purposes of a parcel of land as described in Exhibit "A" attached hereto, from Oregon Food Stores, Inc., an Oregon Corporation, to the City of Canby for the purpose of widening S.W. Berg Parkway in the City of Canby.

<u>Section 2</u>. The Canby City Council directs the Mayor of the City of Canby to execute the Deed for Road Purposes on behalf of the City and insure that it is properly recorded in the Deed Records of Clackamas County, Oregon.
