

## RESOLUTION NO. 905

### A RESOLUTION AMENDING SALARY COMPENSATION SCALES FOR MANAGEMENT LEVEL EMPLOYEES FOR THE CITY OF CANBY, OREGON, PREVIOUSLY ADOPTED BY RESOLUTION NO. 895.

**WHEREAS**, the City of Canby passed Resolution No. 895 on April 20, 2005 establishing salary compensation scales for management level employees, and because the Council now wishes to amend the annual salary rates to increase the rate by a 2.5% cost of living increase for the fiscal year 2005-2006; now therefore

**IT IS HEREBY RESOLVED** by the City of Canby Council as follows:

1. That Attachment "A-1" is attached to this Resolution as Management Salary Schedule Attachment "A-1", and is hereby adopted effective July 1, 2005 and will automatically extend each year until changed by the City Council. The City Council may, in its discretion, grant base pay adjustments at any time to the base salary as set forth in Exhibit "A-1". The cost of living increase included within Attachment "A-1" is not automatically increased each year, but only applies to fiscal year 2005-2006.
2. The rest and remainder of Resolution No. 895 shall remain in full force and effect.
3. That the effective date of this Resolution is August 3, 2005 with a retroactive date to July 1, 2005 for the cost of living increase.
