

Ordinance No. 88.

An Ordinance providing for the Licensing and regulating the carrying on of certain professions, trades, callings, and Occupations conducted within the corporate limits of Canby Oregon.

Canby does Ordain as follows:

Sec. 1. It shall be unlawful for any person, whether as principal, agent, clerk, or employee, either for themselves, or for any other person or bodies, corporate or otherwise, to carry on any trade, profession, or occupation in this Ordinance specified, without first having procured a License from the City of Canby, and each and every day or part of a day that such trade, calling, profession or occupation in this Ordinance specified is conducted or carried on without such License, shall constitute a violation of this Ordinance, and any such persons, who shall conduct, or carry on any trade, calling, profession or occupation aforesaid without first having procured a License, shall for each violation of this Ordinance, be deemed guilty of a Misdemeanor, and upon conviction before the Recorder or Mayor shall be fined therefor in a sum, not exceeding Fifty dollars (\$50.00), or be imprisoned for a term not to exceed Twenty five days, or by both such fine and imprisonment,

Sec. 2. That in every license taken out under or by virtue of this Ordinance, shall be contained, and set forth the purpose, trade, calling, business, profession or occupation for which said license is granted, and the name and place of business of the person taking out the same, and the terms of said license; That licenses for three months in this ordinance provided, shall be due and payable on the first days of January, April, July & October, and shall with the last days of March,

June, September, and December, of each year. The first license of such quarter may be issued for a one-third or two-thirds of such unpaid period.

Sec. 3. That the rates for licenses for the pursuits, trades, callings, business, professions and occupations hereinafter named, be and the same are hereby established for and within the City of Canby, and all licenses so established, and due from any applicant shall be paid in advance to the City Treasurer, thereupon the receipt of the City Treasurer shall be filed with the Recorder, who shall issue a License to the parties applying for such license at the following established rates, to wit:

For every Astrologer, Seer, Fortune teller or Clairvoyant who demands or receives a fee for his or her services, or gives an exhibit at any place where an admission is charged, One dollar per day; Three dollars per week or ten dollars per Quarter.

Auctioneers: For every auctioneer or person who sells jewelry, watches and plated ware at public Auction on commission or otherwise, either for himself or another person Five dollars per day.

For every Auctioneer who sells Cattle, horses or other live stock, or personal property, Two dollars and fifty cents per day, but shall not apply to auction sales by virtue of any decree of Court, or to public sales by executors and administrators or to residents selling out their household goods.

For every pawnbroker, second hand dealer, and junk dealer, One dollar per quarter.

Billiards: For every person conducting a Billiard, bagatel, or Pool table, (excepting only such as are used in private houses) For each and every table, Two dollars per Quarter, and it is further ordained, that no other games shall be played or conducted in any Pool room except the games of Billiard, bagatel or Pool, and furthermore, that no games of any kind be carried on in a Pool room on Sundays.

Bowling - For every person conducting a bowling alley, Three dollars each for every table or alley per. Quarter, every place where bowls are thrown open to the public with or without price, shall be regarded as a bowling alley.

Shooting Gallery - For each shooting gallery, One dollar per. day, Two dollars and Fifty cents per. week. or Five dollars per Quarter.

Skating Rink = For each skating rink, Two dollars and Fifty cents per Quarter, For every traveling exhibition, such as Telescopes, Microscopes, Lung testers, Muscle testers, doll racks, ball, Knife or ring throwing, galvanic batteries, and all similar in character, not otherwise fixed, One dollar and Fifty cents per. day, or Five dollars per. Week.

Swings and Merry grounds = any person running a Swing by hand, shall pay a license fee of Fifty cents per. day; or Two dollars per. week.

For running a Swing by horse power, shall pay One dollar and Fifty cents per. day, or Five dollars per. week.

For running a Swing or Merry ground by Steam, or Electricity shall pay a license of Two dollars and Fifty cents per. day, or Ten dollars per week.

Sec. 4, That the rates for licenses established by this Ordinance shall not apply to any of such pursuits, trades, callings, business, professions and occupations mentioned in Sec. 3. of this ordinance, while the same shall be permitted to be conducted or carried on within the enclosed grounds of the Clackamas County Fair Association during the time that said Association is holding its Annual County Fair, Provided However; that said Association shall not permit or allow any gambling, games of chance, fortune wheels or any kind of devices to be carried on or conducted on its enclosed grounds whereby the people may be defrauded or swindled during said Fair time,

Sec. 5. That all Ordinances, or parts of Ordinances in conflict with this Ordinance are hereby repealed, and that this Ordinance shall take effect and be in full force from and after its final passage and approval by the Mayor.
