ORDINANCE NO. 292(87)

AN ORDINANCE FIXING REGULATIONS UPON THE OWNERSHIP AND USE OF BICYCLES IN THE CITY OF CANBY, PROVIDING A PENALTY, AND DECLARING AN EMERGENCY AND REPEALING ALL ORDINANCES IN CONFLICT HERE-WITH.

The city of Canby does ordain as follows:

Section 1. No person shall ride or operate any bicycle upon any street, alley, or public place within the corporate limits of the city of Canby during the period from a half-hour after sunset until a half-hour before sunrise, and all times when fog or other atmospheric conditions render the operation of said bicycle dangerous to traffic or the use of the streets or at any other time when there is not sufficient light to render clearly discernible any person on the streets a distance of 200 feet ahead, without having a lighted lamp affixed on the front of said bicycle, visible under normal conditions for a distance of at least 300 feet in front of said bicycle, and also a reflex mirror or lighted lamp on the rear of said bicycle exhibiting a red light visible under like conditions from a distance of at least 200 feet to the rear of said bicycle.

Section 2. No person shall operate or ride a bicycle upon any street, alley, or public place in the city of Canby with more than two persons upon the same bicycle; this shall not apply to bicycles equipped to carry two or more riders.

Section 3. No persons, while operating or riding a bicycle upon any street, alley, or public place in Canby, shall hold onto any other vehicle.

Section 4. Traffic rules of the Oregon Motor Vehicle act, applicable to bicycles, shall be observed by all riders of bicycle(s); and it shall be unlawful for more than two riders to proceed abreast or otherwise than in single file.

Section 5. It shall be unlawful to engage in bicycle racing upon the streets and alleys of Canby.

Section 6. Any person violating any of the provisions of this ordinance shall, upon conviction thereof before the city recorder, be punished by impounding his bicycle in the city hall of Canby, in charge of the chief of police for such period as the recorder shall designate, or by a fine not exceeding \$5, as may seem best to the court.

Section 7. No operator of a bicycle shall leave his bicycle lying or standing in such a manner that shall hinder or impede pedestrian or vehicle traffic upon the sidewalks or paths or upon the streets or alleys within the city of Canby but shall take proper care to see that his bicycle is so placed to avoid annoyance and danger of accident during his absence from it.

Section 8. Whereas bicycles are operated in the city of Canby without sufficient regulations, endangering the riders and other persons, an emergency is declared to exist; and it is declared to be necessary for the immediate preservation of the peace, health, and safety of the city of Canby that this ordinance take effect immediately upon its passage by the common council and its approval by the mayor; and it is so ordered.

Read for the first time September 7, 1937, and ordered published and to come up for final passage at the regular meeting of the city council, October 4, 1937.
