ORDINANCE NO. 125.

6305 -

An ordinance providing for a special election for the surpose of submitting to a vote of the legal voters of Canby, in Clackamas County, State of Oregon, for their adoption or rejection, a charter for Canby, and which said proposed charter is entitled as follows: A Bill for an act entitled, "An Act it incorporate Canby in Clackamas County, State of Oregon; fixing the boun aries thereof; providing for the election and appointment of its officers and defining their qualifications, theirduties, their powers, and fixing their terms of office; providing for the organization of the City Council, the manner of passage of ordinances; the establishment or alteration of the grade of any street or alley, and for the improvement thereof, the building and repair of sidewalks, the laying out and establishing of sever districts, and the construction of severs and drains therein, the levying and collecting of assessments and re-assessments for the costs of improvements of streets and alleys and the costruction of severs and drains; providing for a docket of City Liens, for the sale and redemption of property on account of delinquent assessments, for the condemnation of property for public use, for the isuance of bonds, for the owning, building and maintaining of water works for the said city; for the raising and expenditure of public money: for the liebility of Camby; velidating the past acts of Camby; fixing the terms of offices of the present officials, and repealing all acts and parts of acts in conflict therewith."

And also for the purpose of submitting to a vote of the legal voters & Canby, in ClackamasCounty, State of Oregon, for their adoption or rejection, A bill for

an Act entitled: "An act authorizing and empowering Canby to issue water bonds, to build and maintain a a water works system; empowering the Council to issue not to exceed \$18,000.00 of water bonds, and providing that this act shall becme a part of the charter of Canhy to be known as Section 140 of said Charter of Canby, which said charter of Canby is estitled: A Bill for an act entitled: "An act to incorporate Canby, in Clackanas County, State of Oregon; fixing the boundries thereof; providing for the election and appointment of its officers, defining their qualifications, their duties, their powers and fixing their terms of office; providing for the organization of the City Council, the manner of the passage of ordinances, the establishment or alteration of the grade 6 any street or alley, and for the improvement thereof, the building and repair of sidewalks. the laying out and establishing of sewer districts, and the construction of severs and drains therein; the levying and collecting of assessments and re-assessments for the cost of improvements of streets and alleys, and the construction of sewers and drains; providing for a docket of City Liens, for the sale and redemption of property on account of delinquent assessments, for the condemnation of property for public use, for the issuance of bonds, for the owning, building and maintaining of water works for said city; for the raising and expenditure of public money; for the liability of Canby; validating the past acts of Canby; fixing the terms of office of the present officials and repealing all acts and parts of acts in coflict herewith. ""

And also providing for the posting of notices of the said special election; providing for the appointment of judtes and clerks of such election, and fixing their compensation; establishing the election ward or precinct for

said election, and designating the polling place for the same and declaring an emergency by which this ordinance shall become immediately operative. CANBY DOES ORDAIN AS FOLLOWS:-

Section 1, That there shall be held in Canby, Clackmanas County, State of Oregon, on Friday the 19th day of May, A.D. 1916, a special election for the purpose of submitting to a vote of the legal voters of Canby, for their adoption or rejection, a charter for Canby, which said proposed charter is entitled as follows: A Bill for an act entitled: "An act to incorporate Canby, in Clackamas County, State of Oregon; fixing the boundaries thereof; providing for the election and appointment of its officers, and defining their qualifications, their duties, their, powers and fixing their terms of office; providing for the organization of the City Council, the manner of passage of ordinances; the establishment or alteration of the grade of any street or alley, and for the improvement thereof; the building and repair of sidewalks, the laying out and establishing of sewer districts, and the construction of severs and drains therein; the levying and collecting of assessments and re-assessments for the costs of improvements of streets and alleys, and the construction of sewers and drains; providing for a docket of city liens; for the sale and redemption of property on account of delinguent assessments, for the condemnation of property for public use; for the issuance of bonds, for the owning, building and maintaining of water works for the said city; for the raising and expenditure of public money; for the liability of Canby; validating the past acts of Canby; fixing the terms of office of the present officials and repealing all acts and parts of acts in conflict herewith."

And also for the purpose of submitting to a vote of the legal voters of Canby, for their adoption or rejection, "A Bill for an act entitled: An act authorizing and em-

powering Canby, to issue water bonds, to build and maintain a water works system; empowering the council to issue not to exceed \$18,000.00 of water bonds, and providing that this act shall become a part of the charter of Canby to be Imown as Section 140 of said Charter of Canby, which said Charter of Canby is entitled: "A Bill for an act act entitled: An act to incorporate Canby, in Clackamas County, State of Oregon; fixing the boundaries thereof; providing for the election and appointment of its officers, defining their qualifications, their duties, their powers, and fixing their terms of office; providing for the organization of the City Council, the manner of the passage of ordinances, the establishment or alteration of the grade of any street or alley, and for the improvement the eof, the building and repair of sidewalks, the laying out and establishing of sever districts, and the construction of severs and drains therein the levying and collecting of assessments and re-assessments for the cost of improvements of streets and alleys, and the construction of sewers and drains; providing for a docket 8 city liens, for the sale and redemption of property on account of delinquent assessments, for the condemnation of property for public use, for the issuance of bonds, for the owning, building and maintaining of water works for said city, for the raising and expenditure of public money; for the liability of Canby; validating the past acts of Canby; fixing the terms 6 office of the present officials, and repealing all acts and parts of acts in conflict herewith."

Section 2, The Recorder of Canby is hereby authorized and directed to post in six enspicuous and public places within the corporate limits of Canby, in Clackamas County, State of Oregon, for at least ten days prior to Friday, the 19th day of May; A.D. 1916, notices of the special city election to be held in Canby on said date, to-wit: Friday the

19th day of May, A.D. 1916, which said notices of election shall state the date upon which said election shall be held and shall designate the purpose of said election, the polling place therefor, and the hours that said polls shall be kept onen, and shall name the judges and clerks of said election and give the ballot title of the proposed acts to be submitted to a vote of the legal voters of Canby for their adoption or rejection at said special city election.

Section 3, The Council of Canby shall by motion hereafter appoint judges and clerks of such special city election; said judges and clerks shall receive as full compensation for their services as such, the sum of Three Dollars per day each.

Section 4, The election ward or precinct for said special city election shall be and enstitute all the territory included within the corporate limits of Canby.

Section 5, That shall be one polling place for said special city election, to-wit: In the Council Chamber of the City Hall.

Section 6, Whereas, it is necessary that a charter be immediately adopted to preserve the peace, health and safety of said city, and that whereas, it is necessary to immediately build, erect and maintain a water works system within the city to preserve the **peace**, health and safety of Canby and of the citizens of Canby, an emergency is hereby declared and this ordinance shall take effect as soon as it is passed by the Council, signed and approved by the Mayor and attested by the Recorder.

Read for the first time March 13, 1916, and ordered posted for the reason that the charges for publication thereof are in the judgment of the Council, excessive, and said publi, cation is hereby dispensed with, and the same shall be posted in three public and conspicuous places of said city for a period of two full calendar weeks, and to come up for final passage at a regular meeting of the Council of Cabby to be held on the 10th day of April, 1916, at 8 o'clock P.M.
