AN ORDINANCE ADOPTING RULES AND REGULATIONS TO GOVERN AND CONTROL THE USE OF CITY PARKS.

WHEREAS it is the opinion of the Common Council for the City of Canby, Oregon that it is necessary and in the best interest of the residents of the City of Canby that certain rules and regulations should be promulgated and adopted governing the use of city parks to protect the park property as well as to provide the greatest use and benefit of the park facilities to the residents of the City of Canby and the citizens of the neighboring communities, now therefor

THE CITY OF CANBY ORDAINS AS FOLLOWS:

SECTION 1: That the following rules and regulations shall govern and control the use of all city parks in the City of Canby, Oregon:

1. No fire shall be built, lighted or maintained within city parks except in a camp stove or a fireplace provided, maintained or designated for such purposes, excepting however, that gasoline or oil campstoves may be used in established camp sites or picnic areas where other stoves are provided. All fires shall be extinguished by their user before leaving the park.

2. All city parks are game refuges. No person shall discharge any firearm in a city park, and all firearms brought into a city park must be unloaded.

3. No person shall molest, injure or kill any bird or mammal or distunb its habitat in a city park, except for the control of predatory animals and rodents as may be ordered by the Canby City Council.

4. No person shall pick flowers, foliage or cut, break or dig up or in any way mutilate any tree, shrub, plant or fern, or burn, cut or mutilate any railing, building, table, seat, fence or other structure or facilities within a city park.

5. No person shall dig up or remove any dirt, stones, rock or other substance whatever or make any excavation, quarry any stone,

or lay or set off any blast, or cause or assist in doing any of the said things within a city park without permission from the Canby City Council.

6. No person shall erect signs, markers, or inscriptions of any type without permission from the Canby City Council.

7. No person while in a city park may operate a concession, either fixed or mobile, or engage in the business of soliciting, selling or peddling any liquids or edibles for human consumption, or distribute circulars, or hawk, peddle or vend any goods, wares or merchandise in a city park without permission from the Canby City Council.

8. Automobiles, trailers or other vehicles shall be parked only in désignated parking areas.

9. No dogs or other pets shall be allowed in a city park unless said animals are confined in a vehicle or kept on a leask.

10. No bottles, cans, ashes, waste paper, garbage or other rubbish shall be left in a city park except in the receptacles designated for that purpose.

11. No person shall set up or use a public address system in a city park without the permission of the Canby City Council.

12. No person shall build a fire in or set fire to any pile of driftwood or underbrush.

13. No person shall ride, drive, lead or keep a saddle horse or other animal in any city park except on such roads, trails or areas designated for that purpose. No horse or other animal shall be hitched to any tree or shrub in such a manner that may cause damage to such tree or shrub.

14. No person shall wash any clothing or other materials or clean any fish in a stream or river in a city park.

15. No person shall use abusive, threatening, boisterous, vile, obscene or indecent language or gestures in a city park nor shall any person cause, attempt to cause, or bring about any public

demonstrations or disturbances.

16. Over-night camping in City parks is prohibited unless special permission is first obtained from the City Superintendent or the City Councilman in charge of city parks who shall designate the camping area and the length of time over-night camping shall be permitted in each case.

17. In order to enforce all rules and regulations and to maintain a sanitary and orderly appearance in city parks the City employees in charge of city parks are vested with the authority to require all persons using said parks to abide by the rules and regulations as well as the authority to determine the size, type and arrangement of individual camping facilities, and/or picnic facilities in the park.

SECTION 2: Any person found to be violating the provisions of this Ordinance shall be guilty of a misdemeanor, and upon their conviction thereof shall be punished by a fine of not more than \$100.00 or by imprisonment in the County or municipal jail for not more than thirty days, or both.

SECTION 3: The City Superintendent for the City of Canby, Oregon, shall cause to be printed and posted in convenient places within all city parks the foregoing rules and regulations.

<u>SECTION 4:</u> It being deemed by the Canby City Council that an emergency exists and that it is to the best interests of the residents of the City of Canby and essential for the preservation of the peace, health, safety and general welfare of said residents that this Ordinance take effect immediately, it shall take effect immediately upon its final passage by the Council and approval by the Mayor.

Passed on its first reading at a regular meeting of the Canby City Council this 18th day of August, 1958; ordered posted in three public and conspicuous places in the City of Canby as provided by City Charter, and to come up for final reading and action of the City Council at a regular meeting thereof to be held thereof
