## ORDINANCE NO. 424

AN ORDINANCE INCREASING MINIMUM WATER RATES IN THE CITY OF CANBY; AMENDING ORDINANCE NUMBER 313; AND DETERMINING THE EFFECTIVE DATE OF RATE INCREASES.

WHEREAS the minimum monthly rates for water charges in the City of Canby were fixed by Ordinance No. 313 adopted by the Canby City Council January 6th, 1939 and said minimum rates, which are now in effect, are as follows:

Residential rate, minimum charge -	\$1.00
Commercial rate	
3/4 inch meter, minimum charge -	\$1.00
1-1/2 inch meter, minimum charge -	\$3.00
2 inch meter, minimum charge -	\$4.00
3 inch meter, minimum charge -	\$4.00 \$6.00

WHEREAS said minimum charges are unreasonably low and are disproportionate to the actual costs and expenses of maintaining and operating the City's water supply system and facilities; and that an increase in the monthly minimum rates for water is justifiable, now therefore,

THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1: That Rule 15 of Canby City Ordinance No. 313 is hereby amended to provide that the minimum monthly rates for water charges to be made by the City of Canby to its water users shall be as follows:

Residential rate, minimum charge -	\$1.50
Commercial rate: 3/4 inch meter, minimum charge - 1-1/2 inch meter, minimum charge -	\$1•50 \$3•50
2 inch meter, minimum charge -	\$4.50 \$6.50
3 inch meter, minimum charge -	\$0.50

<u>Section 2:</u> That the increased monthly minimum charges for water as determined and fixed by this Ordinance shall take effect on the first day of the month immediately following the final passage and adoption of this Ordinance.

<u>Section 3</u>: That all Ordinances or parts of Ordinances in conflict herewith be and the same are hereby repealed.
