## ORDINANCE NO. 427

AN ORDINANCE CHANGING WATER RATES IN THE CITY OF CANBY; INCREASING THE MINIMUM MONTHLY CHARGES; AMENDING ORDINANCE NUMBER 313; REPEALING ORDINANCE NUMBER 424; and DECLARING AN EMERGENCY.

THE CITY OF CANBY ORDAINS AS FOLLOWS:

<u>Section 1</u>: That Ordinance Number 424, adopted by the Canby City Council June 1, 1959, is hereby repealed; and Rule 15 of Canby City Ordinance Number 313, adopted by the Canby City Council January 6, 1939, is hereby amended to provide as follows:

All water, whether for industrial, commercial or residential purposes, shall be sold in accordance with the schedule of minimum monthly charges and rates set forth herein.

Services  $\mu^{\parallel}$  and larger shall be covered by specific written agreement with the City, but in no case shall the rates and charges be less than set forth above.

<u>Section 2:</u> It being deemed by the Canby City Council that an emergency exists, this Ordinance shall take effect immediately upon its final passage and approval by the Mayor; and the water charges as changed and imposed by this Ordinance shall be applied

to meter readings made during the first calendar month immediately following the month in which this Ordinance is adopted, and to all monthly meter readings thereafter until changed by further Ordinance.
