

ORDINANCE NO. 433

AN ORDINANCE CHANGING WATER RATES IN THE CITY OF CANBY; AMENDING
ORDINANCE NUMBER 430; AND DECLARING AN EMERGENCY.

THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1: That Section 1 of Ordinance No. 430 adopted by the Canby City Council on the 16th day of November, 1959 is hereby amended to provide as follows:

That Ordinance No. 424 adopted by the Canby City Council June 1, 1959 is hereby repealed; and Rule 15 of Canby City Ordinance No. 313 adopted by the Canby City Council January 6, 1939 is hereby amended to provide as follows:

All water, whether for industrial, commercial or residential purposes shall be sold in accordance with the schedule of minimum monthly charges and rates set forth herein.

RATE SCHEDULE:

<u>Amount of water in Cubic Feet</u>	<u>Rate Per 100 Cubic Feet</u>
First 900	\$ 0.27
Next 400	0.25
All over 1300	.09

MINIMUM CHARGES PER MONTH:

<u>Size of Meter & Service Line</u>	<u>Minimum Charge</u>	<u>Cubic Feet of Water Allowed at Minimum Charge</u>
5/8" to 3/4"	\$ 2.50	900
1"	3.50	1300
1 1/2"	7.00	5200
2"	10.00	8500


All services 2 1/2" and larger shall be covered by specific written agreement with the City, but in no case shall the rates and charges be less than set forth above.

Section 2: It being deemed by the Canby City Council that an emergency exists, this Ordinance shall take effect immediately upon its final passage and approval by the Mayor; and the water charges as changed and imposed by this Ordinance shall be applied to meter readings made during the first calendar month

immediately following the month in which this Ordinance is adopted and to all monthly meter readings thereafter until changed by further Ordinance.


Passed on its first reading at a recessed meeting of the Canby City Council this 28th day of March, 1960.

Ordered posted at full length for a period of two full calendar weeks as provided by the Canby City Charter, and to come up for final reading and action at a regular meeting of said Council to be held on the 18th day of April, 1960 at 8:00 o'clock p.m., Oregon Standard Time in the Canby City Hall.




