AN ORDINANCE RELATING TO STREET LIGHTING RATES, COMMERCIAL LIGHTING AND POWER RATES, COMMERCIAL WATER AND SPACE HEATING RATES; AMENDING ORDINANCE NO. 370; AND DECLARING AN EMERGENCY.

The CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1: That paragraph number 1 entitled "ENERGY CHARGE" under the RATE section of the STREET LIGHTING RATE SCHEDULE 4 of Ordinance No. 370 adopted by the Canby City Council December 1, 1952, is hereby amended to provide as follows:

## 1. Energy Charge

First 150 kw-hrs. used per month at  $2\frac{1}{2}e$ 

Next 350 kw-hrs. used per month at  $1\frac{1}{2}e$  per kw-hr.

Excess above 500 kw-hrs. used per month at 0.72 per kw-hr.

Section 2: That billings by the City of Canby under Schedule 2 (COMMERCIAL LIGHTING AND POWER RATE) and Schedule 3 (COMMERCIAL WATER AND SPACE HEATING RATE) of Ordinance No. 370 adopted by the Canby City Council December 1, 1952 shall be discounted ten per cent (10%) on all billings made to public buildings, schools, churches, lodges, clubs and organizations not operated for commercial purposes.

<u>Section 3:</u> That the amended energy charge rate as provided in the foregoing Section 1 of this Ordinance, and the discounted billing rate as provided in the foregoing Section 2 of this Ordinance shall be applied to the first meter readings made after the effective date of this Ordinance, and to all meter readings made thereafter.

<u>Section 4</u>: It being deemed by the Canby City Council that an emergency exists, this Ordinance shall take effect immediately upon its final passage and approval by the Mayor.

Passed on its first reading at a regular meeting of the Canby City Council held this 3 day of Apr. 1961.

Ordered posted at full length for a period of two full calendar weeks as provided by the Canby City Charter, and to come up for final reading and action at a regular meeting of said Council to be held on the /sr day of May, 1961, at 8:00 p.m. Standard Oregon Time in the Canby City Hall.
