

ORDINANCE NO. 470

AN ORDINANCE TO REPEAL CANBY GENERAL ORDINANCES.

The city of Canby ordains as follows:

Section 1. Ordinance No. 62, approved November 4, 1901, relating to removal of moss from roofs, is repealed.

Section 2. Ordinance No. 80, approved April 3, 1907, relating to establishing monuments at street intersections, is repealed.

Section 3. Ordinance No. 81, approved April 3, 1907, relating to defining base of elevation and establishing grades, is repealed.

Section 4. Ordinance No. 117, approved September 15, 1914, relating to regulation of telephone, telegraph, and electric lines, is repealed.

Section 5. Ordinance No. 118, approved September 15, 1914, relating to regulations concerning maps and plats, is repealed.

Section 6. Ordinance No. 122, approved November 1, 1915, relating to fire limits and building regulations, is repealed.

Section 7. Ordinance No. 302, approved January 3, 1939, relating to initiative and referendum, is repealed.

Section 8. Ordinance No. 304, approved January 3, 1939, relating to compensation and bonds of recorder and treasurer, is repealed.

Section 9. Ordinance No. 307, approved January 3, 1939, relating to compensation and bond of night watchman, is repealed.

Section 10. Ordinance No. 311, approved January 6, 1939, relating to fire department, is repealed.

Section 11. Ordinance No. 315, approved January 6, 1939, relating to naming of streets, is repealed.

Section 12. Ordinance No. 330, approved July 7, 1941, relating to Zion Cemetery regulations, is repealed.

Section 13. Ordinance No. 331, approved November 3, 1941, relating to width of streets, is repealed.

Section 14. Ordinance No. 350, approved June 7, 1948, relating to compensation and bonds for city recorder and treasurer, is repealed.

Section 15. Ordinance No. 351, approved June 7, 1948, relating to curbs and sidewalks, is repealed.

Section 16. Ordinance No. 379, approved January 4, 1954, relating to parking regulations, is repealed.


Section 17. Ordinance No. 423, approved April 6, 1959, relating to width and grade of streets, is repealed.
