## ORDINANCE NO. 477

AN ORDINANCE PRESCRIBING CURFEW HOURS FOR MINORS; REPEALING ORDINANCE NO. 310; AND DECLARING AN EMERGENCY.

THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1: Ordinance No. 310 adopted by the Canby City Council January 6, 1939, relating to minors being on the streets or in public places during certain hours is hereby repealed.

<u>Section 2</u>: It shall be unlawful for any minor under 18 years of age to be or remain in or upon any street, highway, park, alley or other public place between the hours specified herein, unless such minor is accompanied by a parent, guardian or other person 21 years of age or over and authorized by the parent or by law to have the care and custody of the minor, or unless such minor is then and there engaged in a lawful pursuit or activity which requires his presence in or upon such street, highway, park, alley or other public place during the hours specified herein. For the purposes of this Ordinance, the applicable hours of curfew shall be:

- (a) As to minors under 14 years of age who have not begun high school, the hours shall be between 9:15 o'clock p.m. and 6:00 o'clock a.m. on the following morning, except that during the months of June, July and August, the hours shall be between 10:15 p.m. and 6:00 a.m. of the following morning.
- (b) As to minors 14 years of age or over, or who have begun high school, the hours shall be between 10:15 o'clock p.m. Sunday, Monday, Tuesday, Wednesday or Thursday, and 6:00 o'clock a.m. of the following morning, and between 12:00 Midnight on Friday or Saturday, or any day prior to a legal holiday when no school is scheduled for said legal holiday, and 6:00 o'clock a.m. of the following morning, except that during the months of June, July and August, the hours shall be between 12:00 Midnight and 6:00 o'clock a.m. of the following.

Section 3: Any minor violating any of the provisions of this Ordinance may be apprehended and taken into custody as provided in O.R.S. 419.569 and may be subjected to further proceedings as provided in O.R.S. 419.472 to 419.587.

Section 4: It being deemed by the Canby City Council that an emergency exists, this Ordinance shall take effect immediately upon its final passage by the Canby City Council and approval by the Mayor.

Passed on first reading at a regular meeting of the Canby City Council this 7th day of December, 1964; ordered posted in three public and conspicuous places in the City of Canby for a period of two (2) calendar weeks as required by the Canby City Charter, and to come up for final reading and action of the Canby City Council at a regular meeting thereof, to be held on the 4th day of January, 1965, at 8:00 o'clock p.m. Pacific Standard Time at the Canby City Hall.
