

ORDINANCE NO. 613

AN ORDINANCE AUTHORIZING PURCHASE OF TWO (2) POLICE CARS;
AND DECLARING AN EMERGENCY.

WHEREAS, the City of Canby has heretofore advertised for and received bids for its purchase of two (2) police patrol cars. The NOTICE OF CALL FOR BIDS was duly and regularly published for two successive issues in The Canby Herald, a newspaper of general circulation printed and published in Canby, Oregon. Said publications were made on November 10, 1976, and November 17, 1976; and

WHEREAS, the bids as advertised were received and publicly opened at the Canby City Hall and considered by the Canby City Council at a regular meeting thereof on Monday, December 20, 1976. Five bids were received as follows:

WHEREAS, the Canby City Council as the City's Contract Review Board has considered the bids and the recommendations of the City Administrator and has determined that the lowest and best bid was that of Moak Chevrolet, Inc. of Canby, Oregon, and funds were budgeted for the purchase of two police car units; now, therefore,

THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1: An emergency is hereby declared to exist, and the Mayor and City Recorder are authorized and directed to make, execute and deliver in the name of the City of Canby and on its behalf a Contract for the immediate purchase from Moak Chevrolet, Inc. of two (2) police patrol cars for \$4,376.29 each, and the total purchase price of \$8,758.58.

Section 2: The total purchase price for the two police patrol cars is to be paid on delivery of the equipment and receipt of the billing and approval of the City Administrator that both units conform to the City's specifications for said equipment from budgeted funds now on hand in the Motor Pool Budget line item.

Section 3: Because of the emergency herein declared to exist and the urgent need for two police patrol cars, this Ordinance shall take effect immediately upon its enactment after final reading.

Passed on first reading at a regular meeting of the Canby City Council on Monday, January 3, 1977; ordered posted in three (3) public and conspicuous places in the City of Canby for a period of two (2) full calendar weeks as required by the Canby City Charter; and to come up for final reading and action of the Canby City Council at a meeting thereof to be held on _____, _____, 1977, at the hour of 8:00 o'clock p.m. at the Canby City Hall.
