ORDINANCE NO. 515

AN ORDINANCE AUTHORIZING THE CONSTRUCTION OF A WATER WELL; DIRECTING THE PAYMENT OF COSTS; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Canby owns and operates a municipal water system which is now inadequate to supply the needs of the City and its residents; and a constant endeavor has been made during the past several months by the City's officials to determine the best and most economical method of correcting the problem which is becoming more serious as the City's population increases, and

WHEREAS, the City's supply of potable water is critically short, and an emergency has developed causing the City Council to direct a call for bids for the construction and development of a new City Water Well, and

WHEREAS, the City Council, anticipating such a problem and the need for funds for such a purpose, adopted a Supplementary Budget for the ensuing fiscal year in order to appropriate \$22,000.00 of water revenue funds to defray the costs of such a project, NOW, THEREFORE,

THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1: That the City of Canby proceed immediately to construct and develop a new City Water Well on the City's right-of-way property at North Cedar Street approximately 150 feet north of Northwest 5th Avenue. The Well hereby authorized to be constructed is to be 12" in diameter when finished and drilled to a maximum depth of 400 feet, unless a greater depth is authorized by a "Change Order" first approved by the City Council. That such Well be constructed in accordance with the plans and specifications therefor, which have been prepared by the City's Consulting Engineers and approved by the City Council; and that the construction be done under the supervision of the City's Superintendent and the Consulting Engineers, Clarke & Groff of Salem, Oregon.

That the City accept a bid and award a contract for the construction and development of the Well to a responsible bidder, who, in the opinion of the City Council, makes the most satisfactory proposal in accordance with the call for bids.

Section 2: That the City of Canby pay the construction costs for the accepted bid from water revenue funds of the City appropriated for such purpose by the 1967-68 Supplementary Budget for the City's Water Department.

Section 3: That the Canby City Council, upon completion and testing of the Well, call for bids for the installation of necessary pumping and electrical facilities and award a contract for purchase of the same to the person, firm or corporation making the bid, deemed by the Council, to be in the best interests of the City and pay the bid price for such materials from the Water Department Funds appropriated by the Supplementary Budget for the ensuing fiscal tax year.

Section 4: That a contract shall be made by the Mayor and City Recorder on behalf of the City with the successful bidders for both the construction and development of the Well and also for the furnishing of the pumping and electrical facilities.


Section 5: It being deemed by the Canby City Council that an emergency exists, this Ordinance shall take effect immediately upon its final passage and approval by the Mayor.

Passed on its first reading at a recessed regular meeting of the Canby City Council this 22nd day of May, 1968.

Ordered posted at full length for a period of two (2) full calendar weeks as provided by the Canby City Charter, and to come up for final reading and action at a regular meeting of said Council to be held at the Canby City Hall at 12:00 o'clock Noon, Oregon Daylight Saving Time, on Monday, June 10, 1968.


