AN ORDINANCE AMENDING THE ZONING MAP OF THE CITY OF CANBY, (Application of Ernest W, Bedwell)

WHEREAS, an Application was filed with the Canby City Recorder on October 11, 1968, by Ernest W. Bedwell, owner of the real property hereinafter described, to amend the zoning map of the City of Canby for the purpose of changing the classification of the zone in which the following described real property is located from Rel (Low Density Residential Zone) to an R-2 (Medium Density Residential Zone), and the application fee as required by Section 32 of Ordinance No. 452 (the City®s Zoning Ordinance) has been paid. The following is a description of the area which consists of less than ten (10) acres of land for which the Application was filed for a zone change, to-wits

A portion of the southerly 90 feet of Lot 70 and the northerly 174 feet of Lot 69, CANBY GARDENS ADDITION to the City of Canby, Clackamas County, Oregon.

WHEREAS, before taking final action on said Application and the proposed amendment, the Canby City Planning Commission held a public hearing thereon and said hearing was conducted on Wednesday, October 23, 1968, at the hour of $8:00 \ o^{\circ} clock p_{em_{\circ}}$, Oregon Daylight Saving Time, at the Canby City Hall in Canby, Clackamas County, State of Oregon, and proper Notice of the time, place and purpose of such hearing was duly given in the manner and for the time required by Section 33 (1) (\acute{a}) of the City Zoning Ordinance No_e 452. Said Notice was given by the Canby City Recorder by mailing written notice on October 14, 1968, to all owners of property within lines parallel to and 200 feet from the exterior boundaries of the property involved, and the City Recorder $^{\circ}$ s Affidavit of such mailing is on file at the Canby City Hall in the records and file of this matter.

WHEREAS, the Canby City Planning Commission at the time and place of the public hearing on such matter heard and considered

arguments for and against the proposed zone change; and upon the conclusion of the hearing by motion duly made, seconded and unanimously carried, recommended to the Canby City Council that the Application of said Ernest W. Bedwell be approved, and that the proposed amendment to the City Zoning Map be made and that the zone classification of the above described real property be changed from that of R+1 (Low Density Residential Zone) to that of R-2 (Medium Density Residential Zone); whereupon a written report and recommendation of the Canby City Planning Commission was duly made and filed with the Canby City Council; and

WHEREAS, the Camby City Council held a public hearing on said Application and the proposed amendment as required by the provisions of Section 33 (3) of the City Zoning Ordinance No. 452, and said public hearing was held on the 22nd day of November, 1968, at the hour of 7:00 o[®]clock p_em_b , Facific Standard Time, at the Camby City Hall in Camby, Clackamas County, State of Oregon, after proper notice thereof was first duly given in the manner and for the time required by the said Zoning Ordinance and O_bR_bS_b 227_c260, and proof of the publication of such Notice in the Camby Herald, a newspaper of general circulation printed and published in Camby, Clackamas County, State of Oregon, is on file in the office of the Camby City Recorder at the Camby City Hall and is a part of the records and file of this matter; and

WHEREAS, three of the neighboring property owners, i.e., Lloyd Gardner, Everett Hoy and James Bergen, voiced orally objections to the proposed zone change contending that it would result in a devaluation of neighboring property, additional traffic on Neff Street and the possible attraction of undesirable elements which might result from a mobile home development project. After extensive public discussion of the matter, the Council after due

consideration and deliberation and after further review and consideration of the reports and recommendations of the Canby City Planning Commission, determined that it would be in the best interest of the City and the inhabitants thereof if the said Application were approved and the proposed zone change and amendment to the City Zoning Map were made as applied for; now, therefore;

THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1: That the zoning map of the City of Canby dated July 15, 1963, and adopted as a part of the City Zoning Ordinance No. 452 adopted July 15, 1963, shall be and the same is hereby amended and changed so that the zone boundaries of the R=2 (Medium Density Residential Zone) shall now include the following described real property, to wit:

A portion of the southerly 90 feet of Lot 70 and the northerly 174 feet of Lot 69, CANBY GARDENS ADDITION to the City of Canby, Clackamas County, Oregon, all being east of N. Neff Street and south of McCurty Subdivision;

and upon the adoption of this Ordinance, said property shall there upon be classified as an R=2 Zone and not as an R=1 Zone.

Section 2: The City Superintendent and the City Recorder are hereby authorized and directed to make the appropriate changes in the City Zoning Map_e

Section 3: It being deemed by the Canby City Council that an emergency exists, this Ordinance shall take effect immediately upon its final reading and passage by the Canby City Council.

Passed on first reading of the Canby City Council at a regular meeting thereof held on the 2nd day of December, 1968; ordered posted as provided by the Canby City Charter and to come up for final reading and action of the Canby City Council at a regular meeting thereof to be held on Monday, the 6th day of January, 1969, at the hour of 8:00 o[©]clock p_em_e , Pacific Standard
