## ORDINANCE NO. 547

AN ORDINANCE AMENDING THE ZONING MAP OF THE CITY OF CANBY (Application of Dr. Edmund E. Davies)

WHEREAS, an Application was filed with the Canby City Recorder on October 13, 1971, by Dr. Edmund E. Davies and approved by Lauren Porter and Phyllis J. Porter, husband and wife, owners of the hereinafter described property, to amend the zoning map of the City of Canby for the purpose of changing the classification of the zone in which the following described real property is located from an R-2 (Medium Density Residental Zone) to a C-1 (General Commercial Zone), and the application fee as required by Section 32 of Ordinance No. 452 (the City's Zoning Ordinance) has been paid. The following is a description of the real property, which consists of less than ten acres, for which the Application for Zone Change was filed, to-wit:

Lots 11 and 12, Block 15, CANBY, Clackamas County, State of Oregon.

WHEREAS, the Canby City Planning Commission, before taking final action on said application and the proposed amendment, scheduled and held a public hearing on the mattermon Wednesday, November 10, 1971, and Notice of the time, place and purpose of said hearing was duly and regularly given by written Notices mailed by the City Recorder to all owners of property within lines parallel to and 200 feet from the exterior boundaries of the property involved as required by Section 33 (1) (b) of the City Zoning Ordinance No. 452, and also (though not required) by publication in the Canby Herald on October 28, 1971, and a record of the property owners to whom Notices were mailed and the newspaper's Affidavit of the publication Notice is on file in the City Recorder's records and file of this zone change matter; and

WHEREAS, the Canby City Planning Commission at the time and place of the public hearing on such matter, i.e., November 10, 1971,

heard and considered discussion for the proposed zone change, and there was no one present who opposed the same; and upon conclusion of the hearing, by motion duly made, seconded and unanimously carried, recommended to the Canby City Council that the proposed zone change be approved, and that the City's zoning map be changed accordingly, and that the zone classification of the above described real property be changed from that of R-2 (medium density residental zone) to a C-1 (general commercial zone); whereupon a written report and recommendation of the Canby City Planning Commission was duly made and filed with the Canby City Council; and

WHEREAS, the Canby City Council held a public hearing on the matter and the proposed zone change as required by the provisions of Section 33 (3) of the City Zoning Ordinance No. 452, and said public hearing was held on Friday, December 3, 1971, at the hour of 7:30 o'clock p.m., Pacific Standard Time, at the Canby City Hall in Canby, Clackamas County, State of Oregon, after proper Notice thereof was first duly given in the manner and for the time required by the said Zoning Ordinance and ORS 227.260, and proof of the publication of such Notice in the Canby Herald, a newspaper of general circulation printed and published in Canby, Clackamas County, State of Oregon, is on file in the office of the Canby City Recorder at the Canby City Hall and is a part of the records and file of this matter; and

WHEREAS, there were no objections raised to the proposed zone change at the hearing before the Canby City Council on Friday, December 3, 1971, and after further consideration of the matter and due deliberation on the report and recommendation of the City Planning Commission, the Canby City Council determined that it would be in the best interest of the City and its inhabitants if the proposed zone change were approved and the City's zoning map were amended accordingly; now, therefore,

## THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1: That the zoning map of the City of Canby dated July 15, 1963, and adopted as a part of the City Zoning Ordinance No. 452 adopted on the same date, shall be and the same is hereby amended and changed so that the zone boundaries of the C-1 (general commercial zone) shall now include the following described real property, to-wit:

Lots 11 and 12, Block 15, CANBY, Clackamas County, State of Oregon:

and upon the adoption of this Ordinance, said property shall thereupon be classified as a C-1 Zone and not as an R-2 Zone.

Section 2: The City Superintendent and the City Recorder are hereby authorized and directed to make the appropriate changes in the City'z Zoning Map.

Section 3: It being deemed by the Canby City Council that an emergency exists, this Ordinance shall take effect immediately upon its final reading and passage by the Canby City Council.

Passed on first reading of the Canby City Council at a regular meeting thereof on the 6th day of December, 1971; ordered posted as provided by the Canby City Charter, and to come up for final reading and action of the Canby City Council at a regular meeting thereof to be held on Monday, the 3rd day of January. 1972. at the hour of 8:00 o'clock p.m., Pacific Standard Time, at the Canby City Hall.
