ORDINANCE NO. 574

AN ORDINANCE FIXING THE TIME AND PLACE OF COUNCIL MEETINGS.

THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1. Regular meetings of the Council of the City of Canby shall be held on the first and third Mondays of every month at 7:30 P.M. in the council chambers of the City Hall. In the event that the first or third Monday of the month is a holiday, the Council meeting shall be held on the following day.

Section 2. Special meetings of the Council may be called by the Mayor or at the request of any three (3) members of the Council on twenty-four (24) hours reasonable notice to the public and at least twenty-four (24) hours actual notice to the Council members.

Section 3. Ordinance No. 303 enacted January 3, 1939 is hereby repealed.

Section 4. This Ordinance shall take effect at the hour of 12:01 A.M., Pacific Standard Time, on Thursday, December 6, 1973.

Passed on first reading at a regular meeting of the Canby City Council held on the 5th day of November, 1973; ordered posted in three public and conspicuous places in the City of Canby for a period of two full calendar weeks as provided by the Canby City Charter, and to come up for final reading and action of the Canby City Council at a regular meeting thereof to be held on the 3rd day of December, 1973 at the hour of 8:00 o'clock P.M., Pacific Standard Time, at the Canby City Hall.
