ORDINANCE NO. 584

AN ORDINANCE AUTHORIZING THE EMPLOYMENT OF ZAROSINSKI-TATONE ENGINEERS, INC. FOR ENGINEERING SERVICES FOR CONSTRUCTION OF A TRUNK SEWER FROM THE SEWAGE TREATMENT PLANT TO SOUTH IVY STREET; AUTHORIZING APPLICATION FOR STATE OR FEDERAL GRANT MONIES OR MATCHING FUNDS; AND AUTHORIZING PAYMENT OF ENGINEERING SERVICES.

WHEREAS, the City has adopted a Master Plan for the City's sanitary sewer system and engineering studies have been authorized and made with regard to the City's storm water drainage system, sanitary sewer collection system and service areas; and

WHEREAS, there is a need at this time to extend a trunk sewer from the City's sewage treatment plant to South Ivy Street, and the firm of Zarosinski-Tatone Engineers, Inc. of Portland, Oregon, has made a proposal at the City's request for engineering service for such project; now, therefore,

THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1: The proposal of Zarosinski-Tatone Engineers,
Inc. made by letter to Mr. Harold Wyman, City Administrator, dated
March 5, 1974, for engineering services for the construction of a
trunk sewer from the sewage treatment plant to South Ivy Street
is accepted. A copy of the proposal is attached marked Exhibit "A"
for identification purposes and is expressly made a part of this
Ordinance.

Section 2: The City Administrator is authorized to make application on behalf of and in the name of the City of Canby for State or Federal grant monies or matching funds which are or might become available for sewer construction of Trunk F, a portion of Trunk E, and Main E-1 as designated in the City's Master Sewer Plan and to which the attached Exhibit "A" relates.

Section 3: Payment to Zarosinski-Tatone Engineers, Inc. on its proposal as per attached Exhibit "A" is authorized to be made as the work progresses and on receipt of proper billings approved by the City Council from City funds previously budgeted and allocated for such purpose.
