

ORDINANCE NO. 595

AN ORDINANCE AUTHORIZING A CONTRACT FOR PURCHASE OF A MOTOR GRADER.

WHEREAS, the City of Canby has heretofore advertised for and received bids for its purchase of a used motor grader for the Street Department; and

WHEREAS, bids as advertised were publicly opened at the Canby City Hall at 2:00 p.m. on Monday, September 29, 1975; and

WHEREAS, the Canby City Council has considered the bids and the recommendations of the City Administrator and also the recommendations of the Public Works Foreman, and has determined that the lowest and best bid was also an acceptable bid for the required equipment, and a Contract for its purchase should be authorized; now, therefore,

THE CITY OF CANBY ORDAINS AS FOLLOWS:


Section 1: The bid of BALZER PACIFIC EQUIPMENT CO. for its sale to the City of Canby of one (1) used motor grader for one-day delivery f.o.b. City Hall, Canby, Oregon, is approved for a total purchase price of \$10,500.00, which includes the bid for one (1) T-500 Galion 1963 model grader, SN T-500 ACO 1963 with Cummins 160 engine with new tires; and that the City's existing old grader be traded in for a down payment at the offered price of \$500.00.

Section 2: That the net purchase price of \$10,000.00 for the equipment as described in Section 1 be paid on delivery of the equipment and receipt of billing with City funds on hand in the current budget and allocated for this purpose; and that the Mayor and City Recorder make, execute and deliver on behalf of the City


any required or necessary Sales Contract or Purchase Order.

Section 3: There is an immediate need for the City's use of a motor grader, and an emergency is therefore hereby declared to exist, and this Ordinance shall take effect immediately upon its enactment after final reading.


