## CRDINANCE NO. 716

AN ORDINANCE AUTHORIZING CONTRACT WITH SMITH AND LOVELESS, INC. FOR PURCHASE OF GRIT REMOVAL EQUIPMENT FOR SEWAGE TREATMENT PLANT; AND DECLARING AN EMERGENCY

WHEREAS, the City of Canby has heretofore advertised for and received a bid for one (1) grit screw conveyor and one (1) Pista Grit removal mechanism according to the plans and specifications which were prepared by the City's engineering firm of Lee Engineering, Inc. of Oregon City, Oregon; and

WHEREAS, the notice and call for bids was duly and regularly given by publication in the Canby Herald and the Daily Journal of Commerce on January 27, February 3 and 10, 1982 and the bids were received and opened in the Canby City Hall on or about the hour of 2:00 o'clock p.m. on Wednesday, February 24, 1982; and

WHEREAS, only one bid was received for this purchase, i.e., from Smith and Loveless, Inc. of 14040 Santa Fe Trail Drive, Lenexa, Kansas for the City's purchase price of \$38,750; and

WHEREAS, the bid as received was less than the Engineer's estimate of \$43,500 and the equipment as bid met the Engineer's specifications and the City's requirements and the City's Engineer has recommended the purchase which is necessary for repairs and improvement to the City's sewage treatment plant, now, therefore,

## THE CITY OF CANBY ORDAINS AS FOLLOWS:

<u>Section 1</u>: A contract or purchase order is authorized to be signed by the Mayor and attested by the City Recorder Pro-tem for the City's purchase of one (1) grit screw conveyor and Pista Grit removal mechanism manufactured by Smith and Loveless Corp. consisting of a gear motor, gear head, paddle drive tube, adjustable paddles and airlift pump for installation in a circular concrete grit chamber for the bid price of \$38,750. The purchase price is to be paid upon delivery of the equipment and its approval by the City's Engineers and upon receipt of billings and approval of the same by the Canby City Council and the Superintendent of Public Works from the City's Sewer Reserve Fund in the 1981-82 budget.

Section 2: Inasmuch as there is an immediate need for the said equipment an emergency is hereby declared to exist and this ordinance shall take effect immediately upon its enactment after final reading.

Submitted to the Council and read the first time at a regular meeting thereof on March 17, 1982; ordered posted as provided by the Canby City Charter and scheduled for second reading and action of the Canby City Council at a regular meeting thereof on April 7, 1982, commencing at the hour of 7:30 o'clock p.m. at the Council meeting chambers at the Canby City Hall in Canby, Oregon.
