ORDINANCE NO. 638

AN ORDINANCE AUTHORIZING PURCHASE OF FOUR (4) POLICE CARS AND ONE (1) STAFF CAR; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Canby has heretofore advertised for bids for its purchase of police patrol cars and another necessary car for City staff. Bids were opened and considered by the City Council on December 1, 1977. There was only one bid received and it did not meet the specifications according to the bid call, and was therefore rejected; and

WHEREAS, the City Council previously determined that there was an urgent need to purchase new replacements or additional motor vehicles for the City's Police Department and City staff and that such need constituted an emergency which justified direct requests to suppliers for quotations on the necessary motor vehicles required by the City; and

WHEREAS, the City's Public Works Department at the direction of the City Council sought and received the following quotations for the City's required police patrol cars and City staff car:

WHEREAS, the Canby City Council as the City's Contract Review Board has considered the bid quotations and the recommendations of the City Administrator and has determined that the lowest and best bid for police patrol cars was that of Moak Chevrolet of Canby, Oregon, who has further agreed to sell the City its requirement of four (4) police patrol cars for a discounted price of \$5,200.00 each, or a total purchase price of four units of \$20,800.00; and that the lowest and best bid for a City staff car was made by the General Services Purchasing Division of the State of Oregon; and

WHEREAS, funds for the City's purchase of three automobile units were previously budgeted in this current fiscal year, and money for two additional units is available from funds in the MOTOR POOL RESERVE FUND; now, therefore,

THE CITY OF CANBY ORDAINS AS FOLLOWS:

<u>Section 1</u>: An Emergency is hereby declared to exist, and the Mayor and City Recorder are authorized and directed to make, execute and deliver in the name of the City of Canby and on its behalf a contract and/or purchase order for the immediate purchase from Moak Chevrolet, Inc. of Canby, Oregon, of four (4) police patrol cars at \$5,200.00 each (total \$20,800.00) and for the immediate purchase from the State of Oregon, General Services Purchasing Division, of one (1) City staff car for \$3,891.17. <u>Section 2</u>: The total purchase price for the four police patrol cars and the one City staff car is to be paid on delivery of the equipment **a**nd receipt of the billings and approval of the City Administrator that all units conform to the City's specifications for said equipment from funds now on hand in the Motor Pool Fund.

<u>Section 3</u>: Because of the emergency herein declared to exist and the urgent need for the four police patrol cars and one City staff car, this Ordinance shall take effect immediately upon its enactment after final reading.

Passed on first reading at a regular meeting of the Canby City Council on Wednesday, March 1, 1978; ordered posted in three (3) public and conspicuous places in the City of Canby for a period of two (2) full calendar weeks as required by the Canby City Charter; and to come up for final reading and action of the Canby City Council at a special meeting thereof to be held on March 22, 1978, at the hour of 8:00 o'clock p.m. at the Council's regular meeting chambers at the Canby City Hall.
