## ORDINANCE NO. 639

AN ORDINANCE AUTHORIZING CONSTRUCTION CONTRACT FOR NORTH MAPLE STREET TENNIS COURTS.

WHEREAS, the City of Canby has heretofore advertised for and received bids for the construction of new tennis courts in the City's North Maple Street Park. The work contemplated consists of site preparation, construction of two integral, doubles asphalt tennis courts and necessary fixtures and equipment, perimeter fencing and all painting of surfaces; and

WHEREAS, the NOTICE OF CALL FOR BIDS was duly and regularly published in the Canby Herald, a newspaper of general circulation printed and published in Canby, Oregon on May 10 and May 17, 1978 and also in the Daily Journal of Commerce on May 11, 1978; and

WHEREAS, bids were received as advertised except that no bids were received on the alternate concrete tennis courts; and the bids received were publicly opened at the Canby City Hall on Tuesday, May 23, 1978. Two (2) bids were received as follows:

WHEREAS, the Canby City Council, as the City's Contract Review Board, on May 24, 1978 considered the bids and the recommendations of the City Administrator and the Superintendent of Public Works, and determined that the lowest and best bid was that of Jim Turin & Sons, Inc.; now, therefore,

THE CITY OF CANBY ORDAINS AS FOLLOWS:

<u>Section 1</u>: The Mayor and City Recorder are hereby authorized and directed to make, execute and deliver in the name of the City of Canby and on its behalf an appropriate contract with Jim Turin & Sons, Inc. of Wemme, Oregon for the construction of tennis courts and related facilities in the City's North Maple Street Park and according to the plans and specifications for said project as prepared by the City's Engineer and Superintendent of Public Works and the amount of such contract is the low bid therefor, i.e. \$33,319.00.

Page 1. ORDINANCE NO. 639

<u>Section 2</u>: The contract price shall be paid upon receipt of billings and approval by the City's Public Works Department and the City Council from funds on hand which were previously budgeted for completion of the City's North Maple Street Park.

<u>Section 3</u>: An emergency is hereby declared to exist in order that the work may be started and completed as soon as possible during this summer season and warm weather which is necessary for a construction project of this kind. Therefore, this Ordinance shall take effect immediately upon its enactment after final reading.

Passed on first reading at a special meeting of the Canby City Council on Wednesday, May 31, 1978; ordered posted in three (3) public and conspicuous places in the City of Canby for a period of two (2) full calendar weeks as required by the Canby City Charter; and to come up for final reading and action of the Canby City Council at a regular meeting thereof on Wednesday, June 21, 1978, at the hour of 8:00 o'clock p.m. at the Council's Regular Meeting chambers at the Canby City Hall.
