## AN ORDINANCE AUTHORIZING PURCHASE OF A 15 PASSENGER VAN FOR SENIOR CITIZENS' PROGRAM; AND DECLARING AN EMERGENCY

WHEREAS, the City of Canby has heretofore advertised for bids for its purchase of a 15 passenger van for its Senior Citizens' Program, which involves necessary transportation for qualified members of that group to and from meetings, luncheons and similar types of community programs; and,

WHEREAS, a call for bids for the required vehicle was duly and regularly published in the Canby Herald on August 23, 1978, and the bids received were opened at the City Administrator's office at the Canby City Hall at 2:00 o'clock p.m. on August 28,1978; and,

WHEREAS, a total of four bids were received according to the plans and specifications of such item as prepared by the City Administrator and his staff, and the following are the bids which were received:

WHEREAS, the Canby City Council, as the City's Contract review Board, has considered the bids and the recommendations of staff and has determined that the lowest and best bid was made by Jack Thomas Motors Inc. for the base price of \$7,531.00, but optional air conditioning Page 1. ORDINANCE NO. 644. should also be purchased for a total bid and purchase price of \$8,144.50; and,

WHEREAS, funds for the City's purchase of the said van are included in this current year's budget under receipts for Federal Revenue Sharing and the item to be purchased and the expenditure of funds for that purpose qualify for the use of said Federal Revenue Sharing money; now therefore,

THE CITY OF CANBY ORDAINS AS FOLLOWS:

<u>Section 1</u>: The Mayor and City Recorder are authorized and directed to make, execute and deliver in the name of the City of Canby and on its behalf the Contract and/or Purchase Order for the immediate purchase from Jack Thomas Motors Inc. of one 1978 new 15 passenger Dodge van including air conditioning for a total price of \$8,144.50 and for immediate delivery to the City.

<u>Section 2</u>: Inasmuch as the required Senior Citizens' van is immediately available to the City and the bid price was conditioned on immediate acceptance, and inasmuch as the City's Senior Citizens' Program is in urgent need of transportation for participants in that program, an emergency is hereby declared to exist and this Ordinance shall take effect immediately upon its enactment after final reading. <u>Section 3</u>: The total purchase price of the said van is to be paid on delivery and receipt of billing and approval by the City Administrator that the unit conforms to the City's specifications for said equipment

from funds now on hand in the City's Federal Revenue Sharing item.
