## ORDINANCE NO. 656

AN ORDINANCE AUTHORIZING CONTRACTS FOR CUSHION TURF AND PAVING FOR MAPLE STREET PARK PHASE II, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Canby has heretofore advertised for and received bids for the installation of cushion turf and required paving for the parking lot and basketball court in Phase II of the Maple Street Park construction project. An invitation to bid on the "cushion turf" project was published in the Canby Herald on April 25, 1979, and also in the Daily Journal of Commerce on April 19, 1979. An invitation to bid on paving the parking lot and basketball court was published in the Canby Herald on April 25, 1979, and also in the Daily Journal of Commerce on April 19, 1979. The City Engineer's estimate of the "cushion turf" project was \$28,500 and his estimate for the required paving projects was \$20,700, or a total estimated cost of \$49,200; and

WHEREAS, the Canby City Council as the City's contract review board, met in regular session on May 2, 1979, and considered the bids and reports and recommendations of the City Engineer, and determined and declared by motion that each of the two bids received on the two separate projects in this phase of the construction projects were less than the estimates of the City Engineer and the bids accepted and contracts authorized for the immediate construction of the required facilities; now therefore,

THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1: The Mayor and City Recorder are hereby authorized and directed to make, execute and deliver in the name of the City of Canby and on its behalf an appropriate contract with Olympic Constructior Company of Bremerton, Washington, for the installation of the cusmon turf in Maple Street Park, Phase II, according to the plans and specifications for such project as prepared by the City's Engineer and Superintendent of Public Works, and the amount of such contract is the bid quote of \$25,200.

<u>Section 2:</u> The Mayor and City Recorder are hereby authorized and directed to make, execute and deliver in the name of the City of Canby and on its behalf an appropriate contract with Parker Northwest Paving Co. of Oregon City, Oregon, for the required paving of the parking lot and basketball court in Maple Street Park, Phase II, according to the plans and specifications for that phase of the project as prepared by the City's Engineer and Superintendent of Public Works, and the amount of such contract is the bid quote of \$13,198.

Page 2. Ordinance No. 656

Section 3: The contract price in each case shall be paid upon completion of the work and receipt of billings and upon approval of the City Engineer and City Council from revenue sharing funds previously budgeted for Phase II of the Maple Street Park Improvement Project.

Section 4: An emergency is hereby declared to exist in order that the work may be started and completed as soon as possible and during this summer season since use of the park is increasing and public need for an early completion of the total project is apparent.

Submitted to the council and read the first time at a regular meeting thereof on Wednesday, May 14, 1979, and scheduled for second reading and action of the Canby City Council at a regular meeting thereof to be held on Wednesday, June 6, 1979, commencing at the hour of 7:30 o'clock P.M. at the Council Meeting Chambers at the Canby City Hall in Canby, Oregon.
