

ORDINANCE NO. 670

AN ORDINANCE AUTHORIZING CONTRACT FOR LIGHTING FIXTURES AND MATERIAL FOR BALLFIELDS AND TENNIS COURT IN MAPLE STREET PARK PHASE III; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Canby has heretofore advertised for and received bids for the installation of lighting fixtures for the ballfields and tennis court in Phase III of the Maple Street Park project. An invitation to bid on the lighting fixtures and material for the Maple Street Park ballfields and tennis court was published in the Canby Herald on September 19, 1979, and also in the Daily Journal of Commerce on September 18, 1979. The City Engineer's estimate for the ballfields project was \$17,612, and his estimate for the tennis court project was \$7,398, or a total estimated cost of \$25,010; and

WHEREAS, the following bids were received, opened, and publicly read aloud in the Canby City Hall at 2:00 o'clock P.M., on October 2, 1979, which was the scheduled time for bid opening:

WHEREAS, the Canby City Council as the City's contract review Board, met in regular session on October 3, 1979, and considered the bids and reports and recommendations of the City Engineer, and determined that the bid of Amfac Electric Supply of Clackamas, Oregon,

did not meet specifications and that the lowest and best bid was that of Platt Electric Supply in the sum of \$18,220 for the ballfields fixtures and materials and in the amount of \$6,852.30 for the tennis court fixtures, for a total bid of \$25,072.30. By motion duly made, seconded and unanimously adopted, the Canby City Council/ Contract Review Board approved the acceptance of said bid of Platt Electric Supply, the award of the contract to such bidder, and authorized this ordinance, as required by the City Charter, now therefore,

THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1: The Mayor and City Recorder are hereby authorized and directed to make, execute and deliver in the name of the City of Canby and on its behalf an appropriate contract with Platt Electric Supply of Portland, Oregon, in the amount of \$18,220 for the ballfields fixtures and materials; and in the amount of \$6,852.30 for the tennis court fixtures, for a total contract price of \$25,072.30.

Section 2: The contract price shall be paid upon completion of the work and receipt of the billings and upon approval of the City Engineer and City Council from the City's Park Construction and Development Fund.


Section 3: An emergency is hereby declared to exist in order that the work may be started and completed as soon as possible before the onset of winter weather, and this ordinance shall take effect immediately upon its enactment after final reading.

Submitted to the Council and read the first time at a regular

meeting thereof on Wednesday, October 17, 1979, and scheduled for second reading and action of the Canby City Council at a regular meeting thereof to be held on Wednesday, November 7, 1979, commencing at the hour of 7:30 o'clock P.M. at the Council Meeting Chambers at the Canby City Hall in Canby, Oregon.
