

ORDINANCE NO. 671

AN ORDINANCE AUTHORIZING CONTRACT FOR DOUGLAS FIR POLES
REQUIRED FOR BALLFIELDS LIGHTING PROJECT IN MAPLE STREET
PARK PHASE III PROJECT; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Canby has heretofore advertised for and received bids for Douglas Fir poles required for the ballfields lighting project in Maple Street Park. An invitation to bid on said project was published in the Canby Herald on September 19, 1979, and the Daily Journal of Commerce on September 18, 1979. The City Engineer's estimate for said poles was \$750; and

WHEREAS, the following bids were received, opened, and publicly read aloud in the Canby City Hall at 2:00 o'clock P.M., on October 2, 1979, which was the scheduled time for bid opening:

WHEREAS, The Canby City Council as the City's contract review Board, met in regular session on October 3, 1979, and considered the bids and reports and recommendations of the City Engineer, and determined that the bid of McCormick & Baxter of Portland, Oregon was the lowest and best bid. By motion duly made, seconded and

unanimously adopted, the Canby City Council/Contract Review Board approved the acceptance of said bid of McCormick & Baxter of Portland, Oregon, in the amount of \$827 each for poles required for the ballfields lighting in accordance with the bid specifications and for the total number of poles as may be specified by the City's Superintendent of Public Works; award of the contract to such bidder, and authorized this ordinance as required by the City Charter, now therefore,

THE CITY OF CANBY ORDAINS AS FOLLOWS:

Section 1: The Mayor and City Recorder are hereby authorized and directed to make, execute and deliver in the name of the City of Canby and on its behalf an appropriate contract with McCormick & Baxter of Portland, Oregon, in the amount of \$827 each for poles required for the ballfields lighting, in accordance with the bid specifications and for the total number of poles as may be specified by the City's Superintendent of Public Works.

Section 2: The contract price shall be paid upon delivery of the total number of poles as may be specified by the City's Superintendent of Public Works and upon receipt of the billings and approval of the City's Engineer and City Council from the City's Park Construction and Development Fund.

Section 3: An emergency is hereby declared to exist in order that the work may be started and completed as soon as possible before the onset of winter weather, and this ordinance shall take effect immediately upon its enactment after final reading.

Submitted to the Council and read the first time at a regular

meeting thereof on Wednesday, October 17, 1979, and scheduled for second reading and action of the Canby City Council at a regular meeting thereof to be held on Wednesday, November 7, 1979, commencing at the hour of 7:30 o'clock P.M. at the Council Meeting Chambers at the Canby City Hall in Canby, Oregon.
